MAKING AN APPROPRIATION TO PROVIDE FUNDING DEVELOPMENT

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifty thousand dollars  
(\$50,000) is appropriated from the general fund to the New  
Mexico office of Indian affairs for expenditure in fiscal year  
1999 for the purpose of contracting to provide funding  
development services to organizations providing services to  
single Native American parents in Albuquerque. Any unexpended  
or unencumbered balance remaining at the end of fiscal year  
1999 shall revert to the general fund.
