BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifty thousand dollars  
(\$50,000) is appropriated from the general fund to the  
economic development department for expenditure in fiscal year  
1999 for the purpose of contracting to produce a native  
Americas international film exposition. Any unexpended or  
unencumbered balance remaining at the end of fiscal year 1999  
shall revert to the general fund.
