AN ACT

REVERTING THE BALANCE OF THE FISCAL YEAR 1998 APPROPRIATION TO THE OFFICE OF THE NATURAL RESOURCES TRUSTEE TO THE GENERAL FUND; REPEALING SECTIONS OF THE NMSA 1978; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. REVERSION OF FUNDS. --The balance of the fiscal year 1998 appropriation to the office of the natural resources trustee is reverted to the general fund on the effective date of this section.

Section 2. REPEAL. --Sections 75-7-1 through 75-7-5 NMSA 1978 (being Laws 1993, Chapter 292, Sections 1 through 5) are repealed.

Section 3. EMERGENCY. --It is necessary for the public peace, health and safety that this act take effect immediately.
