20 protective padding and supervision on public school buses;

21 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
22 STATE OF NEW MEXICO that the legislative education study
23 committee be requested to study the accident and injury rate
24 on school buses and establish cost-effective recommendations
25 to improve the safety of New Mexico's students, including the
