HIGHWAY 126/NEW MEXICO FOREST HIGHWAY 12 FROM LA CUEVA TO  
CUBA.

WHEREAS, the federal government has a forest highway  
program to pave United States forest roads; and

WHEREAS, state highway 126 in the Santa Fe national  
forest is also designated as forest road 12; and

WHEREAS, the forest highway program should fund the  
paving of state highway 126/forest road 12; and

WHEREAS, the road is slated for improvement, but the  
forest highway program allocation to New Mexico is only three  
million dollars (\$3,000,000) to four million dollars  
(\$4,000,000) a year for all forest roads in the state;
