11 REQUESTING THE STATE DEPARTMENT OF PUBLIC EDUCATION TO ENDORSE  
12 A GOVERNMENT-SCHOOL PARTNERSHIP BY DEVELOPING A PILOT PROGRAM

14 WHEREAS, a chronic shortage of qualified substitute  
15 teachers exists in the public school system; and

16 WHEREAS, it is difficult for public schools to attract  
17 qualified substitute teachers when the schools cannot provide  
18 high pay, job security or benefits to substitute teachers; and

19 WHEREAS, frequently, the lack of substitute teachers  
20 requires classes to be combined or to be in the charge of  
21 unqualified people; and

22 WHEREAS, government employees and retired government  
23 employees comprise a large pool of highly qualified potential  
24 substitute teachers; and

25 WHEREAS, the national governors' association has endorsed

1 a public-private partnership to foster a renewed national  
2 commitment to community service and volunteerism;

3 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE  
4 STATE OF NEW MEXICO that the state department of public  
5 education be requested to study the potential for using state,  
6 federal, city and county public employees and retired public  
7 employees as volunteer substitute teachers; and

8 BE IT FURTHER RESOLVED that the state department of  
9 public education develop a pilot program to eventually expand  
10 to the rest of the state; and

11 BE IT FURTHER RESOLVED that copies of this memorial be  
12 transmitted to the superintendent of public instruction.
