A JOINT MEMORIAL

REQUESTING THAT THE LABOR DEPARTMENT NOT DIRECT A PERSON TO PROVIDE HIS SOCIAL SECURITY NUMBER ON THE OUTSIDE OF AN ENVELOPE USED BY THAT DEPARTMENT TO PROCESS UNEMPLOYMENT COMPENSATION CLAIMS.

WHEREAS, the labor department currently directs a person to provide his social security number on the outside of an envelope used by the department to process unemployment compensation claims; and

WHEREAS, many people are wary of writing their social security number in plain view on the outside of an envelope, due to privacy concerns;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the labor department not direct a person to provide his social security number on the outside of
