6 WHEREAS, to conduct a study of this magnitude, the New
7 Mexico legislative council needs to appoint a small committee
8 and provide staff support;

9 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
10 STATE OF NEW MEXICO that the New Mexico legislative council
11 appoint a small committee to conduct a long-range, statewide
12 corrections and crime control planning study; and

13 BE IT FURTHER RESOLVED that the legislative council
14 service be directed to provide for adequate staff, including
15 contract staff if necessary, to assist the committee in its
16 work to conduct long-range planning for corrections and crime
17 control, including monitoring the initiatives of the executive
18 in this area; and

19 BE IT FURTHER RESOLVED that copies of this memorial be
20 sent to the co-chairmen of the New Mexico legislative council,
21 the secretaries of the departments of public safety and
22 corrections and the director of the criminal and juvenile
23 justice coordinating committee.
