



C. Amounts set out in Section 4 of the General Appropriation Act of 1999, or so much as may be

The state budget division shall monitor revenue received by agencies from sources other than the general fund and shall reduce the operating budget of any agency whose revenue from such sources is not meeting projections. The state budget division shall notify the legislative finance committee of any operating budget reduced pursuant to this subsection.

G. Except as otherwise specifically stated in the General Appropriation Act of 1999, appropriations are made in that act for the expenditures of agencies and for other purposes as required by existing law for fiscal year 2000. If any other act of the first session of the forty-fourth legislature changes existing law with regard to the name or responsibilities of an agency or the name or purpose of a fund or distribution, the appropriation made in the General Appropriation Act of 1999 shall be transferred

1 from the agency, fund or distribution to which an appropriation has been made as required by existing law 2 to the appropriate agency, fund or distribution provided by the new law.

3 H. In August, October, December and May of fiscal year 2000, the department of finance and 4 administration, in consultation with the staff of the legislative finance committee and other agencies, 5 shall prepare and present revenue estimates to the legislative finance committee. If these revenue 6 estimates indicate that revenues and transfers to the general fund, excluding transfers to the general fund 7 operating reserve, the risk reserve, the appropriation contingency fund or the state-support reserve fund, 8 as of the end of fiscal year 2000, are not expected to meet appropriations from the general fund, then the 9 department shall present a plan to the legislative finance committee that outlines the methods by which the 10 administration proposes to address the deficit.

11 I. Pursuant to Sections 6-3-23 through 6-3-25 NMSA 1978, agencies whose revenue from 12 unforeseen federal funds, from state board of finance loans, from revenue appropriated by other acts of 13 the legislature, or from gifts, donations, bequests, insurance settlements, refunds, or payments into 14 revolving funds exceed specifically appropriated amounts may request budget increases from the state budget 15 division. If approved by the state budget division, such money is appropriated. In approving a budget 16 increase from unforeseen federal funds, the director of the state budget division shall advise the 17 legislative finance committee as to the source of the federal funds and the source and amount of any 18 matching funds required.

J. For fiscal year 2000, the number of permanent and term full-time equivalent positions specified for each agency shows the maximum number of employees intended by the legislature for that agency, unless another provision of the General Appropriation Act of 1999 or another act of the first

K. Except for gasoline credit cards used solely for operation of official vehicles and
 telephone credit cards used solely for official business, none of the appropriations contained in the
 General Appropriation Act of 1999 may be expended for payment of credit card invoices.
 L. To prevent unnecessary spending, expenditures from the General Appropriation Act of 1999
 for gasoline for state-owned vehicles at public gasoline service stations shall be made only for
 self-service gasoline; provided that a state agency head may provide exceptions from the requirement to
 accommodate disabled persons or for other reasons the public interest may require.

9 M. When approving operating budgets based on appropriations in the General Appropriation Act 10 of 1999, the state budget division is specifically authorized to approve only those budgets that are in 11 accordance with generally accepted accounting principles for the purpose of properly classifying other 12 financing sources and uses, including interfund, intrafund and interagency transfers.

N. Laws 1998, Chapter 116, Section 4 is repealed effective July 1, 1999.

14 The rate of distribution of the state equalization guarantee distribution shall be based on a program 15 unit value determined by the superintendent of public instruction. The superintendent of public 16 instruction shall establish a preliminary unit value to establish tentative budgets for the 1999-2000 17 school year; and then upon completion of final budgets or verification of the number of units statewide 18 for fiscal year 2000, but no later than January 31, the superintendent of public instruction may adjust 19 the program unit value.

Included in the state equalization guarantee distribution is eleven million dollars (\$11,000,000)
for the purpose of funding additional program units to implement a four-year phase-in of early childhood
education. The state department of public education shall distribute funds, upon program approval, to
school districts that develop optional preschool and literacy programs to meet developmental and literacy
needs of children age three through grade two. Such programs may include full-day kindergarten,
half-day, summer or transition programs for children ages three through five or intensive literacy

programs for programs for students in kindergarten through second grade to ensure that all children are reading by the time they enter grade three. The department shall report progress of school districts on the implementation of phase one and projected costs for phase two to the legislative education study committee and the legislative finance committee by November 1999.

5 The appropriation for the state equalization guarantee contains sufficient funds to provide a five 6 percent salary increase for teachers and at least an average three and one-half percent salary increase 7 for other certified and non-certified staff including transportation employees.

8 (1) Those districts that receive an increase in program cost that meets or exceeds the percentage
 9 increase in the program unit value shall budget a five percent salary increase for teachers and at least
 10 an average three and one-half percent salary increase for other certified and non-certified staff
 11 including transportation employees.

12 (2) Those districts that have a percentage increase in program costs less than the percentage 13 increase in the program unit value shall provide an average salary increase for all public school 14 employees including transportation that meets or exceeds the district's percentage increase in program 15 cost with primary emphasis on improving teacher salaries.

16 The general fund appropriation in the state equalization guarantee distribution reflects the 17 deduction of federal revenues pursuant to Paragraph (2) of Subsection C of Section 22-8-25 NMSA 1978 that 18 includes payments commonly known as "impact aid funds" pursuant to 20 USCA 7701 et seq., formerly known 19 as "PL874 funds".

20 The general fund appropriation to the public school fund shall be reduced by the amounts transferred 21 to the public school fund from the current school fund and from the federal Mineral Lands Leasing Act 22 receipts otherwise unappropriated.

Any unexpended or unencumbered balance in the distributions authorized remaining at the end of
 fiscal year 2000 from appropriations made from the general fund shall revert to the general fund.

Pursuant to Sections 6-3-23 through 6-3-25 NMSA 1978, agencies whose revenue from 6 unforeseen federal funds, from state board of finance loans, from revenue appropriated by other acts of the 7 legislature, or from gifts, grants, donations, bequests, insurance settlements, refunds, or payments into 8 revolving funds exceed specifically appropriated amounts may request budget increases from the state budget 9 division. If approved by the state budget division, such money is appropriated. In approving a budget 10 increase from unforeseen federal funds, the director of the state budget division shall advise the 11 legislative finance committee as to the source of the federal funds and the source and amount of any 12 matching funds required.

#### Section 11. BUDGET REVIEW AND ADJUSTMENT PROJECT .--

A. The state budget division and the legislative finance committee shall conduct a joint executive-legislative "budget review and adjustment project" involving select executive agencies that is designed to provide the executive and legislature with the ability to monitor and analyze the existing budget adjustment procedures and to strengthen the accountability of the budget adjustment request process. The project shall be structured by the state budget division and the legislative finance committee so as to provide the executive and the legislature with the necessary information and tools to effectively evaluate expenditures for necessary government functions and to provide long-range stewardship of state assets.

B. The agencies are the attorney general, the taxation and revenue department, the general services department, the state fair, the human services department, the department of health, the children, youth and families department, the corrections department, the road betterment division of the state highway and transportation department, the state investment council, the educational retirement board and the public employees retirement association.

C. The project shall establish the mechanism for budget increases or budget transfers of the agencies identified in Subsection B of this section, including a procedure for certification of the need for an increase or transfer. In addition to the procedures provided in Sections 6-3-23 through 6-3-25 NMSA 1978 for request and approval of a budget adjustment, budget increases or budget transfers allowed in this section for the agencies are subject to the conditions and procedures provided in Subsections D and E of this section.

D. As a condition precedent to an approval by the department of finance and administration of a budget increase or budget transfer for an agency, the department shall certify to the legislative finance committee that a request meets the following conditions:

10 (1) the agency is not requesting budget increase authority or transfer authority to fund a 11 purpose or program that has not been approved by the legislature for that agency;

12 (2) the agency is not requesting an expansion to fund a program change that was not approved 13 by the legislature;

14 (3) the agency certifies that an emergency or a serious change in circumstance exists that 15 requires immediate funding; and

16 (4) the agency is not attempting, either directly or indirectly, to delegate its powers and 17 duties.

18 E. Upon receipt of the certification by the department of finance and administration that a 19 budget increase or transfer request pursuant to the project meets the conditions set out in Subsection D of 20 this section, the legislative finance committee may raise objections to the certification within thirty 21 days of receipt of the certification. If no objections are raised by the legislative finance committee 22 within that time, the committee is deemed to have concurred with the certification by the department. If 23 the legislative finance committee raises objections to the certification, it shall attempt to resolve the 24 issues with the state budget division pursuant to the procedures developed for the project. The 25 legislative finance committee may hold hearings on its objections to any certification. If the amount of
