20	A. [There is created] The "board of pharmacy" <u>is</u>
21	created. The board consists of nine members, each of whom
22	shall be a citizen of the United States and a resident of New

24	B. [Five] <u>Four</u> members shall be pharmacists
25	appointed by the governor for staggered terms of five years

Thereafter] Appointments of pharmacist 8 members shall be made for five years or less each and made in 9 such a manner that the term of one pharmacist member expires 10 One pharmacist member shall be on July 1 of each year. 11 appointed from each pharmacy district. Each pharmacist member 12 of the board shall have been actively engaged in the 13 pharmaceutical profession in this state for at least three 14 years immediately prior to his appointment and shall have had a minimum of eight years of practical experience as a 15 16 pharmacist. A vacancy shall be filled by appointment by the 17 governor for the unexpired term from lists submitted by the 18 New Mexico pharmaceutical association to the governor. 19 Pharmacist members shall reside in the district from which 20 they are appointed.

C. Three members of the board shall be appointed by the governor to represent the public. The public members of the board shall not have been licensed as pharmacists or have any significant financial interest, whether direct or indirect, in the profession regulated. member's term shall be filled by appointment by the governor for the unexpired term. Initial appointments of public members shall be made for staggered terms of five years or less each and made in such a manner that not more than two public members' terms shall expire on July 1 of each year.

D. One member of the board shall be a pharmacist appointed at large from a list submitted to the governor by the New Mexico society of health systems pharmacists. The member shall be appointed by the governor to a term of five years. A vacancy in the member's term shall be filled by appointment by the governor for the unexpired term from a list submitted to the governor by the New Mexico society of health systems pharmacists.

E. Beginning July 1, 1999, one member of the board shall be a chain pharmacy pharmacist appointed at large from a list submitted to the governor by the New Mexico retail association's chain drugstore pharmacy standing committee. The member shall be appointed by the governor to a term of five years. A vacancy in the member's term shall be filled by appointment by the governor for the unexpired term from a list submitted to the governor by the New Mexico retail association's chain drugstore pharmacy standing committee. For purposes of this subsection, "chain pharmacy" means a corporate grouping of four or more pharmacies in the state.
