**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:**

**Section 1. APPROPRIATION. --Pursuant to Section 6-21-6.1  
NMSA 1978, one million six hundred eighty-six thousand two  
hundred seventy-nine dollars (\$1,686,279) is appropriated from  
the public project revolving fund to the drinking water state  
revolving loan fund for expenditure in fiscal year 1999 and  
subsequent fiscal years to carry out the purposes of the  
Drinking Water State Revolving Loan Fund Act. Any unexpended  
or unencumbered balance remaining at the end of any fiscal  
year shall not revert to the public project revolving fund.**

**Section 2. EMERGENCY. --It is necessary for the public**
