The "commission on African American affairs" is Α The commission shall consist of nine members created. appointed by the governor to represent all fields of interest to African Americans. Members shall be appointed for staggered terms. Of the initial board, the terms of three members expire June 30, 2000, the terms of three members expire June 30, 2001 and the terms of three members expire June 30, 2002; thereafter, appointments shall be for terms of three years made in such manner that the terms of three members expire on June 30 of each year. Members shall be appointed so as to represent all areas of the state. No more than five members shall belong to any one political party.

B. A majority of the commission's members constitutes a quorum for the transaction of business. The governor shall designate a chairman and vice chairman from among the membership. The commission may elect other officers as it deems necessary.

C. The commission shall meet as often as it deems necessary, but at least quarterly. Meetings shall be held at the call of the chairman or a majority of the commission.

D. Members of the commission may be reimbursed as nonsalaried public officials as provided in the Per Diem and Mileage Act and shall receive no other compensation,

The fund shall be 20 administered by the office, and disbursements from the fund 21 shall be made on warrant drawn by the secretary of finance and 22 administration pursuant to vouchers signed by the director of 23 the office or his authorized representative. Expenditures of 24 general fund and other state fund appropriations shall be 25 subject to appropriation by the legislature and pursuant to a . 125851. 1

budget approved by the state budget division of the department of finance and administration.

APPROPRIATION. -- Two hundred thousand dollars Section 7. (\$200,000) is appropriated from the general fund to the office on African American affairs fund for expenditure in fiscal year 2000 to carry out the provisions of the African American Affairs Act. Any unexpended or unencumbered balance remaining at the end of fiscal year 2000 shall not revert to the general 8 fund.

EFFECTIVE DATE. -- The effective date of the Section 8. provisions of this act is July 1, 1999.




