

16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. Section 2-4-1 NMSA 1978 (being Laws 1967,
18	Chapter 234, Section 1, as amended) is amended to read:
19	"2-4-1. COMMISSION FOR PROMOTION OF UNIFORMITY OF
20	LEGISLATION IN THE UNITED STATESThere is created a
21	"commission for the promotion of uniformity of legislation in
22	the United States". Its membership shall consist of:
23	A. two members appointed by the New Mexico
24	legislative council, who shall be members of the legislature;
25	B. [two] <u>four</u> members of the New Mexico bar, who
