**C**. Prior to the issuance of a permit, the constituent agency may require the submission of plans, specifications and other relevant information that it deems necessary.

D. The commission shall by regulation set the 8 dates upon which applications for permits shall be filed and designate the time periods within which the constituent agency shall, after the filing of an administratively complete application for a permit, either grant the permit, grant the permit subject to conditions or deny the permit.

The constituent agency shall deny any Ε. application for a permit or deny the certification of a federal water quality permit if:

the effluent would not meet applicable (1) state or federal effluent regulations, standards of performance or limitations;

(2)any provision of the Water Quality Act would be violated:

(3) the discharge would cause or contribute to water contaminant levels in excess of any state or federal Determination of the discharges' effect on ground standard. water shall be measured at any place of withdrawal of water for present or reasonably foreseeable future use.

application for a permit without opportunity for a public hearing at which all interested persons shall be given a reasonable chance to submit data, views or arguments orally or in writing and to examine witnesses testifying at the hearing.

G. The commission may adopt regulations for the operation and maintenance of the permitted facility, including requirements, as may be necessary or desirable, that relate to continuity of operation, personnel training and financial responsibility, including financial responsibility for corrective action.

H. Permits shall be issued for fixed terms not to exceed five years, except that for new discharges, the term of the permit shall commence on the date the discharge begins, but in no event shall the term of the permit exceed seven years from the date the permit was issued.

I. By regulation, the commission may impose reasonable conditions upon permits requiring permittees to:

(1) install, use and maintain effluentmonitoring devices;

(2) sample effluents and receiving waters for any known or suspected water contaminants in accordance with methods and at locations and intervals as may be prescribed by the commission;

(3) establish and maintain records of the nature and amounts of effluents and the performance of

J. The commission shall provide by regulation a schedule of fees for permits, not exceeding the estimated cost of investigation and issuance, modification and renewal of permits. Fees collected pursuant to this section shall be deposited in the water quality management fund.

K. The issuance of a permit does not relieve any person from the responsibility of complying with the provisions of the Water Quality Act, any applicable regulations or water quality standards of the commission or any applicable federal laws, regulations or standards.

L. A permit may be terminated or modified by the constituent agency that issued the permit prior to its date of expiration for any of the following causes:

(1) violation of any condition of the permit;
(2) obtaining the permit by misrepresentation
or failure to disclose fully all relevant facts;

The commission may designate a hearing 13 officer to take evidence in the hearing. If there is an 14 opportunity for a hearing before the constituent agency, the commission's review of the constituent agency's decision shall 15 16 be based upon the record before the constituent agency. Additional evidence may be presented if that evidence could 17 18 not be presented at the constituent agency hearing and the 19 additional evidence is material and is not cumulative. If new 20 evidence is presented, the commission shall remand the matter to the constituent agency on the additional evidence. Based 21 22 upon the [<del>evidence presented at the hearing</del>] record before the 23 commission, including additional evidence presented to the 24 constituent agency, the commission shall sustain, modify or 25 reverse the action of the constituent agency.
