AN ACT

RELATING TO COURTS; PROVIDING THAT THE THREE MAGISTRATES IN THE MCKINLEY MAGISTRATE DISTRICT SHALL OPERATE AS A SINGLE COURT IN GALLUP; AMENDING A SECTION OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 35-1-20 NMSA 1978 (being Laws 1968, Chapter 62, Section 22, as amended) is amended to read:

"35-1-20. MAGISTRATE COURT--MCKINLEY DISTRICT.--There shall be three magistrates in McKinley magistrate district, divisions 1, [and] 2 and 3 operating as a single court in Gallup [and division 3 in Thoreau]. The division 3 magistrate shall ride circuit to Thoreau as needed."

Section 2. EFFECTIVE DATE.--The effective date of the provisions of this act is July 1, 1999.
