

14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:	
15	Section 1. APPROPRIATIONTwo million dollars	
16	(\$2,000,000) is appropriated from the general fund to the	
17	state department of public education for expenditure in fiscal	
18	years 2000 and 2001 for the purpose of supporting the	
19	development, implementation and evaluation of school-based	
20	performing and visual arts education programs in elementary	
21	schools. The appropriation shall be distributed by the state	
22	department of public education to local school districts for	
23	up to twenty school-based programs. Any unexpended or	
24	unencumbered balance remaining at the end of fiscal year 2001	
25	shall revert to the general fund.	



1	Section 2. APPLICATION PROCESS FOR PILOT PROGRAM
2	A. The state department of public education, in
3	collaboration with the arts division of the office of cultural
4	affairs, shall establish a process for schools to apply for a
5	school-based performing and visual arts education pilot
6	program. The application shall include the following options:
7	(1) direct instruction, including personnel;
8	(2) professional development for elementary
9	teachers to explore arts integration methodologies;
10	(3) curriculum development; and
11	(4) community partnerships.
12	B. Each applicant shall perform a results-based
13	evaluation. The pilot programs shall implement the state
14	board of education's content standards and benchmarks for the
15	visual and performing arts.
