"health facility" means any public hospital, 2 D. profit or nonprofit private hospital, general or special 3 4 hospital, outpatient facility, maternity home or shelter, adult day-care facility, nursing home, intermediate care 5 facility, boarding home not under the control of an 6 7 institution of higher learning, child-care center, shelter 8 care home, diagnostic and treatment center, rehabilitation 9 center, infirmary, community mental health center or a health service organization operating as a free-standing hospice or a 10 11 home health agency. The designation of these entities as 12 health facilities is only for the purposes of definition in 13 the Public Health Act and does not imply that a free-standing 14 hospice or a home health agency is considered a health facility for the purposes of other provisions of state or 15 16 "Health facility" also includes those federal laws. 17 facilities which, by federal regulation, must be licensed by 18 the state to obtain or maintain full or partial, permanent or 19 temporary federal funding. It does not include the offices 20 and treatment rooms of licensed private practitioners; and
