RELATING TO EDUCATION; ESTABLISHING AN ALTERNATIVE SCHOOL IN SANDOVAL COUNTY; MAKING AN APPROPRIATION.

Section 1. A new section of the Public School Code is enacted to read:

- A. The department of education shall establish the "alternative education pilot program" in Sandoval county to provide alternative educational programs to students in grades eight through twelve to run from July 1, 1999 to June 30, 2003.
