## AN ACT

MAKING AN APPROPRIATION TO STUDY THE FEASIBILITY AND COST OF ESTABLISHING A STATE VETERANS' CEMETERY AT FORT STANTON.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

#### Section 1. APPROPRI ATI ON. --

Fifteen thousand dollars (\$15,000) is appropriated from the general fund to the New Mexico veterans' service commission for expenditure in fiscal year 2000 to study the cost and feasibility of establishing a state veterans' cemetery at Fort Stanton. The general services department in cooperation with the New Mexico veterans' service commission shall conduct a study to determine the cost and feasibility of establishing a state veterans' cemetery at Fort Stanton.
