### AN ACT

RELATING TO LICENSING; CHANGING PROVISIONS OF THE COUNSELING AND THERAPY PRACTICE ACT; AMENDING AND REPEALING SECTIONS OF THE NMSA 1978.

[ The initial professional members shall meet requirements for licensure and be licensed within one year after the effective date of the licensure requirements.] The professional mental health counselor shall also represent the registered <u>independent and licensed</u> mental health counselors; and

- (2) four members shall represent the public. The public members shall not have been licensed or have practiced as counselor or therapist practitioners or in any other regulated mental health profession, nor have any significant financial interest, either direct or indirect, in the professions regulated.
- C. All members of the board shall be appointed by the governor for staggered terms of four years [ except that . 126218.2

the initial board shall be appointed so that the terms of one professional and one public member expire June 30, 1994, the terms of one professional and one public member expire June 30, 1995, the terms of one professional and one public member expire on June 30, 1996 and the terms of one professional and one public member expire June 30, 1997. The alcohol and drug abuse counselor shall be appointed to a four-year term beginning July 1, 1996]. Each member shall hold office until his successor is appointed. Vacancies shall be filled in the same manner as original appointments. No appointee shall serve more than two terms.

- D. The governor may appoint professional board members from a list of nominees submitted by qualified individuals and organizations, including the New Mexico counseling association, the New Mexico association for marriage and family therapy, the New Mexico art therapy association and the alcohol and drug directors association.
- E. Members of the board shall be reimbursed as provided in the Per Diem and Mileage Act and shall receive no other compensation, perquisite or allowance.
- F. The board shall elect annually from its membership a chairman and a secretary and other officers as necessary to carry out its duties.
- G. The board shall meet at least twice a year and at other times deemed necessary. Other meetings may be called .126218.2
