AN ACT

RELATING TO AUDITING; ALLOWING THE STATE AUDITOR TO AUDIT  
ASSOCIATIONS OR ORGANIZATIONS THAT RECEIVE OR EXPEND PUBLIC  
MONEY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 12-6-2 NMSA 1978 (being Laws 1969,  
Chapter 68, Section 2) is amended to read:

"12-6-2. DEFINITION.--As used in the Audit Act, "agency"  
means:

A. any department, institution, board, bureau,  
court, commission, district or committee of the government of  
the state, including district courts, magistrate or  
metropolitan courts, district attorneys and charitable  
institutions for which appropriations are made by the  
legislature;
