FOR THE REVENUE STABILIZATION AND TAX POLICY COMMITTEE

AN ACT

RELATING TO MUNICIPALITIES; AUTHORIZING A MUNICIPAL BOAT STORAGE FEE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 3-38-3 NMSA 1978 (being Laws 1981, Chapter 37, Section 3, as amended) is amended to read:

"3-38-3. AUTHORIZATION FOR BUSINESS REGISTRATION FEE--  
BOAT STORAGE FEE. --

A. In addition to the licensing authority contained in Section 3-38-1 NMSA 1978, a municipality shall, by ordinance, charge a business registration fee on each place of business conducted within a municipality that is not licensed by the municipality under Section 3-38-1 NMSA 1978. The business registration fee shall not be more than thirty-five dollars (\$35.00) a year and may be prorated for

1 businesses conducted for a portion of the year.

2 B. A municipality may impose by ordinance a boat  
3 storage fee on each place of business conducted within the  
4 municipality that in the previous calendar year derived at  
5 least seventy-five percent of its revenue from storage of  
6 boats. The boat storage fee shall not exceed two percent of  
7 the revenue derived by the business from storage of boats  
8 within the municipality. For purposes of this subsection,  
9 "boat" means any watercraft used or capable of being used as a  
10 means of transportation on water, whether propelled by  
11 machinery or sail.

12 [~~B-~~] C. Notwithstanding the provisions of this  
13 section and Section 3-38-1 NMSA 1978:

14 (1) no license fee or business registration  
15 fee shall be imposed on any sanctioned and registered athletic  
16 official who officiates for any association or organization  
17 which regulates any public school activity and whose rules and  
18 regulations are approved by the state board of education; and

19 (2) a municipality may exempt from the  
20 business regulation fee imposed by the municipality any part-  
21 time artist whose income from sales of his artwork in the  
22 prior taxable year did not exceed one thousand dollars  
23 (\$1,000). "
