AN ACT

**MAKING AN APPROPRIATION TO THE LEGISLATIVE COUNCIL SERVICE TO
PROVIDE A DISTRICT OFFICE AND STAFF FOR EACH LEGISLATOR.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

**A. One million three hundred thirty thousand
dollars (\$1,330,000) is appropriated from the general fund to
the legislative council service to provide a district office
and staff for each legislator for expenditure in fiscal year
2000 as follows:**

**(1) six hundred thirty thousand dollars
(\$630,000) to be divided equally among the members of the
senate; and**

**(2) seven hundred thousand dollars (\$700,000)
to be divided equally among the members of the house of**

2 B. The New Mexico legislative council shall
3 develop policies, procedures and limitations regarding the use
4 of these expenditures by the legislative council service on
5 behalf of the members. Any unexpended or unencumbered balance
6 remaining at the end of fiscal year 2000 shall revert to the
7 general fund.
