AN ACT

MAKING AN APPROPRIATION FOR WOMEN'S SPORTS AT CERTAIN PUBLIC
POST-SECONDARY EDUCATIONAL INSTITUTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Eight hundred twenty thousand dollars
(\$820,000) is appropriated from the general fund for
expenditure in fiscal year 2000 for the purpose of increasing
women's sports activities to comply with Title 9 of the
federal Education Amendments of 1972 to the following entities
in the following amounts:

(1) three hundred thousand dollars (\$300,000)
to the board of regents of the university of New Mexico;

(2) three hundred thousand dollars (\$300,000)
to the board of regents of New Mexico state university;

1 (3) fifty thousand dollars (\$50,000) to the
2 board of regents of western New Mexico university;

3 (4) fifty thousand dollars (\$50,000) to the
4 board of regents of eastern New Mexico university;

5 (5) fifty thousand dollars (\$50,000) to the
6 board of regents of New Mexico highlands university;

7 (6) thirty-five thousand dollars (\$35,000) to
8 the board of regents of New Mexico institute of mining and
9 technology; and

10 (7) thirty-five thousand dollars (\$35,000) to
11 the governing board of New Mexico junior college.

12 B. Any unexpended or unencumbered balance
13 remaining at the end of fiscal year 2000 shall revert to the
14 general fund.
