AN ACT

RELATING TO STATE FUNDS; MAKING AN APPROPRIATION OF THE
BALANCE OF THE NEW MEXICO TECH SINKING FUND TO THE BOARD OF
REGENTS OF THE NEW MEXICO INSTITUTE OF MINING AND TECHNOLOGY
FOR CERTAIN PURPOSES; REPEALING A CERTAIN SECTION OF THE NMSA
1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- The balance of the New Mexico
tech sinking fund is appropriated to the board of regents of
the New Mexico institute of mining and technology for the
purpose of expanding science and technology programs.

Unexpended or unencumbered balances shall not revert at the
end of any fiscal year.

Section 2. REPEAL. -- Section 21-11-28 NMSA 1978 (being
Laws 1982, Chapter 4, Section 5) is repealed.
