AN ACT

RELATING TO MOTOR VEHICLES; PROVIDING FOR THE USE OF VEHICLES WITH SPECIAL DEALER PLATES BY CERTAIN COACHES AND ATHLETIC DIRECTORS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 66-3-401.1 NMSA 1978 (being Laws 1998, Chapter 48, Section 9) is amended to read:

"66-3-401.1. [~~OPERATION OF VEHICLES UNDER SPECIAL COLLEGIATE REGISTRATION PLATES~~] USE OF VEHICLES WITH SPECIAL DEALER PLATES BY COACHES AND ATHLETIC DIRECTORS. --

A. [~~In lieu of the use of special dealer plates~~]

Pursuant to Section 66-3-401 NMSA 1978, a dealer may register [~~and title~~] a vehicle in the name of the dealer [~~pursuant to the provisions of Section 66-3-416 NMSA 1978~~] for the purpose of providing the use of a vehicle from the inventory of the

1 dealer to a full-time coach or athletic director at any state-  
2 supported four-year institution of higher education in New  
3 Mexico.

4 B. ~~Each~~ A vehicle that a dealer elects to  
5 register pursuant to Subsection A of this section is not  
6 required to be titled pursuant to the provisions of the Motor  
7 Vehicle Code, but ~~such~~ the vehicle must be included in the  
8 driver's inventory for Internal Revenue Code of 1986 purposes  
9 and transferred to the full-time coach or athletic director  
10 under conditions that require the dealer to report the value  
11 of the use of the vehicle as income to the full-time coach or  
12 athletic director.

13 C. The number of vehicles registered and used  
14 pursuant to the provisions of this section shall be excluded  
15 when determining compliance with the maximum number of special  
16 dealer plates allowed pursuant to Subsection B of Section  
17 66-3-402 NMSA 1978. "

18 Section 2. EMERGENCY.--It is necessary for the public,  
19 peace, health and safety that this effect immediately.
