16 for office space in Santa Fe and Albuquerque; and

17 WHEREAS, the property control division of the general
18 services department is continuing to pursue consolidation of
19 office space for use by state agencies; and

20 WHEREAS, co-locating offices provides greater
21 accessibility to the public served by state agencies; and

22 WHEREAS, housing state agencies in buildings owned by the
23 state results in significant recurring savings in agency
24 operating budgets; and

25 WHEREAS, the capitol buildings planning commission has

2 enhance the initiative to guide future building projects at

4 WHEREAS, there has been interest since 1986 in adding
5 state-owned office space at the central capital complex; and

6 WHEREAS, there are other properties that may provide
7 other cost-effective options for co-locating state services;

8 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
9 STATE OF NEW MEXICO that the property control division of the
10 general services department be requested to explore purchase
11 of the public employees retirement association and national
12 education association buildings, two residences on Don Gasper
13 in the area of the central capital complex and the unoccupied
14 facilities at Budagers on interstate 25 between Santa Fe and
15 Albuquerque; and

16 BE IT FURTHER RESOLVED that the property control division
17 report its progress to the capitol buildings planning
18 commi ssi on; and

19 BE IT FURTHER RESOLVED that a copy of this memorial be
20 transmitted to the property control division of the general
21 services department and the capitol buildings planning
22 commi ssi on.
