SECTION 5. [<u>NEW MATERIAL</u>] VOCATIONAL REHABILITATION OFFICE--POWERS AND DUTIES.--

The "vocational rehabilitation office" is 4 Α. 5 The commission shall appoint a director, who shall be created. the administrative officer of the commission. The director 6 7 shall be appointed without reference to party affiliation and 8 solely based on the grounds of fitness to perform the duties of 9 the director's office. The director shall employ staff necessary for the effective operation of the commission. 10

B. The office may:

(1) promulgate and enforce rules for the administration of the Vocational Rehabilitation Act and state laws relating to vocational rehabilitation;

[NEW MATERIAL] VOCATIONAL REHABILITATION--2 ELIGIBILITY REQUIREMENTS. -- Vocational rehabilitation shall be 3 provided to a person who: is a resident of the state at the time of filing 4 Α. 5 an application for vocational rehabilitation; and is eligible for a vocational rehabilitation 6 Β. 7 program; or 8 C. qualifies for eligibility under the terms of an 9 agreement that the state has with the federal government or 10 with another state. SECTION 8. [NEW MATERIAL] HEARING.--A fair hearing shall 11 12 be provided for a person applying for or receiving vocational 13 rehabilitation who is aggrieved by an action or inaction of the 14 commission or office pursuant to the Administrative Procedures Act. 15 [NEW MATERIAL] THIRD-PARTY LIABILITY .--16 SECTION 9. The office shall make reasonable efforts to 17 Α. ascertain any legal liability of third parties that are or may 18 19 be liable to pay all or part of the cost of rehabilitation 20 services of an applicant or client of vocational rehabilitation. 21 When the office provides vocational 22 Β. rehabilitation services to a qualified person, the office is 23 subrogated to any right of the individual against a third party 24 25 for recovery of costs incurred.

A vocational rehabilitation provider shall not: 8 engage in administering a vocational (1) 9 rehabilitation program or use the person's official authority 10 or influence to interfere with any public election or partisan 11 political campaign; 12 take an active part in the management of a (2) political campaign or participate in any political activity 13 14 beyond the person's constitutional rights of voting and of free 15 speech; or (3) be required to contribute or render 16 17 service, assistance, subscription, assessment or contribution for any political purpose. 18 19 Β. A person that violates the provisions of this 20 section shall be subject to discharge or suspension. SECTION 12. [NEW MATERIAL] ADMISSION TO STATE EDUCATIONAL 21 INSTITUTIONS--EXEMPTION FROM CERTAIN FEES.--Upon written 22 request of the commission, all state educational institutions 23 shall accept for admission, without any charge for any fees 24 25 except tuition charges, a person with a disability meeting the .221169.1

[There is created] The "interagency behavioral health purchasing collaborative" is created, consisting of the secretaries of aging and long-term services; Indian affairs; human services; health; corrections; children, youth and families; finance and administration; workforce solutions; public education; and transportation; the directors of the administrative office of the courts; the New Mexico mortgage finance authority; the governor's commission on disability; the developmental disabilities [planning] council; the instructional support and vocational [rehabilitation] education division of the public education department; and the New Mexico health policy commission; and the governor's health policy coordinator, or their designees. The collaborative shall be chaired by the secretary of human services with the respective secretaries of health and children, youth and families alternating annually as co-chairs.

B. The collaborative shall meet regularly and at the call of either co-chair and shall:

G. The collaborative shall, through the human services department, submit a separately identifiable consolidated behavioral health budget request. The consolidated behavioral health budget request shall account for requested funding for the behavioral health services program at the human services department and any other requested funding for behavioral health services from agencies identified in Subsection A of this section that will be used pursuant to Paragraph (5) of Subsection B of this section. Any contract proposed, negotiated or entered into by the collaborative is subject to the provisions of the Procurement Code.

н. The collaborative shall, with the consent of the governor, appoint a "director of the collaborative". The director is responsible for the coordination of day-to-day activities of the collaborative, including the coordination of staff from the collaborative member agencies.

I. The collaborative shall provide a quarterly report to the legislative finance committee on performance outcome measures. The collaborative shall submit an annual report to the legislative finance committee and the interim legislative health and human services committee that provides information on:

All instruction shall be free. Deaf or Ε. hard-of-hearing children from other states or territories may be received and educated in the school under such rules and regulations as the board of regents may prescribe, but in no event shall such children be admitted except upon the payment or guaranty of at least one thousand dollars (\$1,000) for the school year, on the basis of nine months for a school year.
