SUMMARY

Synopsis of SFC Amendment to Senate Bill 1

The Senate Finance Committee amendment to Senate Bill 1 creates a new Section 7 that identifies \$50 thousand in unexpended balances to the Legislative Finance Committee to conduct a program evaluation of the state's administration of the Supplemental Nutrition Assistance Program including issuance of benefits to recipient. Preliminary findings are to be reported to the Legislature on January 20, 2026, and a final report to be provided to the Legislative Finance Committee on or before July 1, 2026.

Synopsis of Senate Bill 1

Senate Bill 1 appropriates \$75 thousand from legislative cash balances for the Second Special Session of the Fifty-Seventh Legislature (Section 1), appropriates \$100 thousand of general fund revenue to the Administrative Office of the Courts (AOC) for security and equipment (Section 2), provides contingent appropriations to provide federal Supplemental Nutrition Assistance Program (SNAP) funding to address the failure of the federal government to provide funding (Section 3), sweeps \$162.5 million from previous appropriations to provide a revenue source for funding SNAP benefits (Section 4), replenishes the appropriation contingency fund (\$30 million from the general fund operating reserve), sets contingencies for transfers of operating reserve balances to the Medicaid trust fund, and provides the governor with \$60 million in additional transfer authority for FY25.

FISCAL IMPLICATIONS

In Section 1, from legislative cash balances, Senate Bill 1 appropriates \$32 thousand for expenses of the House of Representatives, \$26 thousand for expenses of the Senate, and \$17 thousand for expenses of the Legislative Council Service in FY26, with any unexpended balances at the end of FY26 reverting back to legislative cash balances.

In Section 2, Senate Bill 1 appropriates \$100 thousand in FY26 to the Administrative Office of the Courts (AOC) for enhanced security protocols, equipment, and infrastructure with unexpended balances reverting to the general fund.

In Section 3, Senate Bill 1 appropriates \$20 million a week, starting with the governor's signature on the bill and through January 19, 2026, from the general fund operating reserve to the Income Support Division of the Health Care Authority (HCA) contingent on expenditure of previous appropriations from the First Special Session, expenditure of balances of previous weekly funding provided in Section 3, and failure of the federal government to provide sufficient funding to pay full SNAP benefits. According to HCA, New Mexico recently received full November SNAP benefits from the federal government, so the first week of potential appropriations needed for lack of federal funding would be in December. Should the federal government not provide funding for December or January benefits, Senate Bill 1 could provide up to an estimated eight weeks or \$160 million in funding to backfill those benefits if contingencies of Senate Bill 1 are met. Any unexpended balance at the end of each weekly period will revert to the general fund operating reserve.

In Section 4, Senate Bill 1 sweeps several balances totaling \$162.5 million from previous appropriations made to the Health Care Authority, its predecessor the Human Services Department, and the Department of Health.

In Section 5, Senate Bill 1 transfers \$30 million from the general fund operating reserve to the appropriation contingency fund (Subsection A). Additionally, Section 5 implements contingency language to move money from the operating reserve to the Medicaid trust fund. If on January 23, 2026, reversions to the general fund operating reserve from the \$162.5 million in sweeps from Section 4 exceed \$137 million, the excess amount would be transferred to the Medicaid trust fund (Subsection B). Similarly, if between January 24 and May 1, 2026, the balance of the general fund operating reserve exceeds \$137 million, any revenue received by the state from the federal government to repay or reimburse state funds beginning November 1, 2025, for SNAP would be

transferred to the Medicaid trust fund (Subsection C.).

In Section 6, Senate Bill 1 provides the governor with transfer authority for up to \$60 million from the general fund operating reserve to the general fund appropriation account, contingent on Board of Finance approval, if revenues and transfers to the general fund at the end of FY25 are not sufficient to meet appropriations. The transfer authority adds to existing transfer authority provided in the 2024 General Appropriations Act which provided authority for \$105 million.

SIGNIFICANT ISSUES

Relating to Section 5, Subsection C, regarding federal repayment or reimbursement, the U.S. Department of Agriculture said in a <u>recent memo</u>, "There is no provision or allowance under current law for states to cover the cost of benefits and be reimbursed." Based on this guidance, it is possible New Mexico will not be repaid or reimbursed for the cost of providing funding for SNAP benefits in lieu of federal funding. As such, the \$30 million in general fund previously issued for SNAP benefits through Executive Order 2025-381 and any future funding issued to fill gaps left by the federal government might not be reimbursed by the federal government.

According to DFA, the requested transfer authority in Section 6 is necessary to ensure constitutional compliance for fiscal year 2025 and avoid an audit finding of an unconstitutional deficit. DFA states the state has sufficient resources to meet appropriations, but transfer authority needs to be increased from the previous level of \$105 million to \$165 million.
