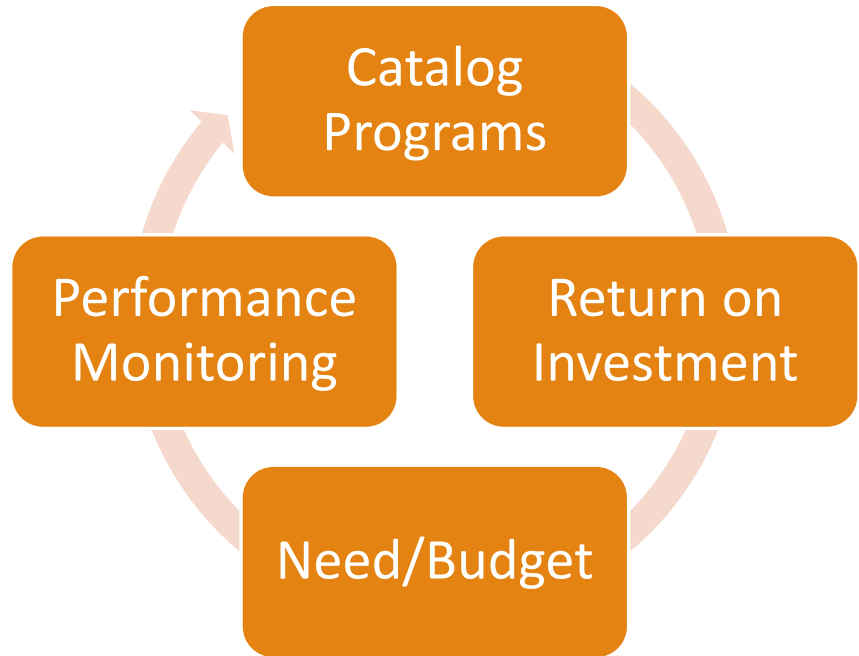

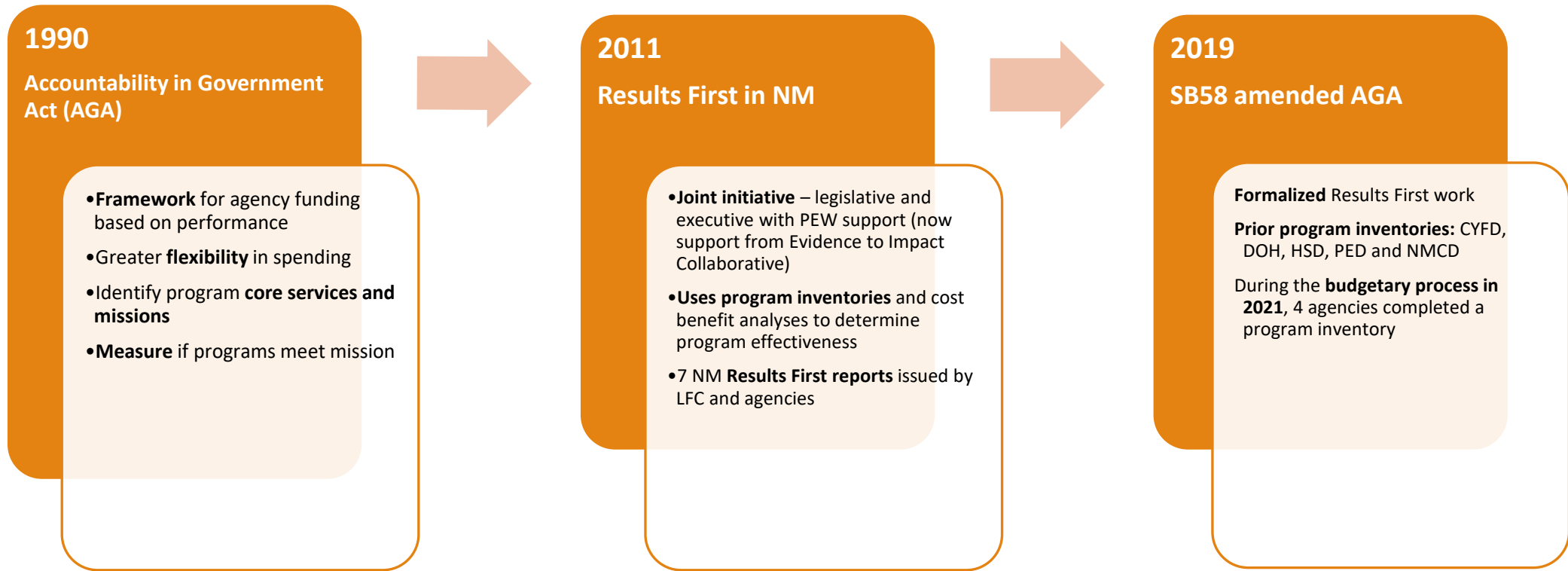
# Evidence-based policymaking framework

---



1. Program Inventories categorize available, evidence-based programs
2. Use findings to craft a budget that prioritizes high-impact programs to high-risk or high-need areas.
3. Monitor performance, ensuring expected effect

AGENCIES/LEGISLATURE CAN USE THIS INFORMATION TO DIRECT FUNDING TO WHAT WORKS



# What does SB58 do?

1. Avenue for agencies to collect information about programs

2. Provides definitions of evidence

3. Outlines deliverables for agencies to submit with their budget

✓ Results of the program inventory

✓ Summary of how the agency has prioritized evidence-based programs in FY26 appropriation request

Establish a baseline

Evaluation decisions

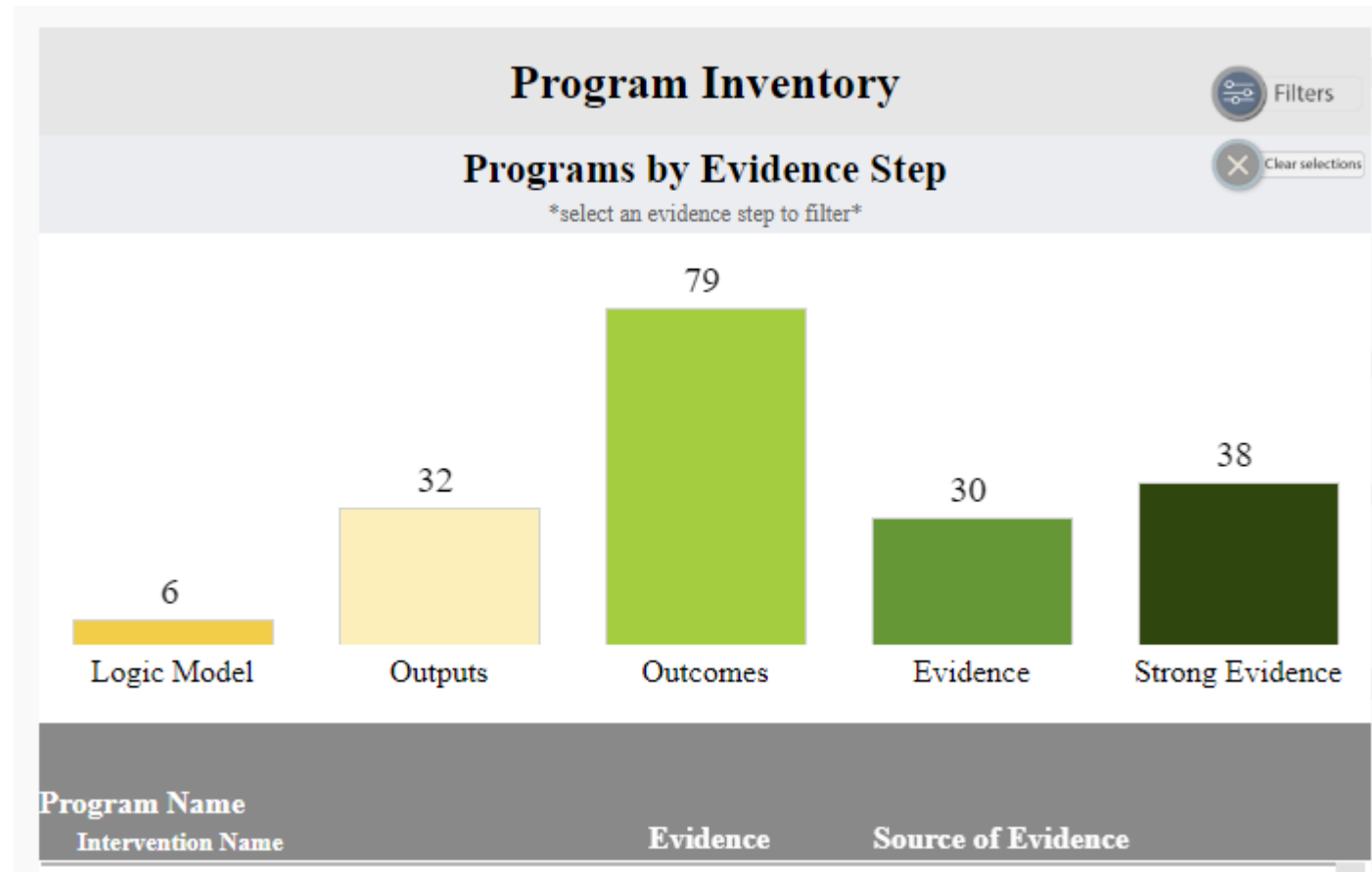
- Identify programs that need evaluation
- Use data collection as a check on program fidelity

Identify program capacity issues

# Moving Forward

---

## CHECK-INS ARE OPPORTUNITIES FOR STATUS UPDATES, QUESTIONS AND ASSISTANCE

- **By the End of May:** Technical assistance meetings between agency, and DFA/LFC.
- **June through August:** meet with your DFA/LFC contact at least monthly to work on inventory
- **July 22<sup>nd</sup>:** can submit draft inventory for feedback.
- **Week of August 5<sup>th</sup>:** receive feedback if submit inventory
- **September 1, 2024:** Completed program inventory and summary paragraph due as part of the FY26 appropriation request to DFA and LFC.



# Senate Bill 58: Definition of Evidence- Based Programs

---

## **New Mexico's Evidence Definitions**

### **Evidence-based**

A program or practice: (1) incorporates methods demonstrated to be effective for the intended population through scientifically based research, including statistically controlled evaluations or randomized trials; (2) can be implemented with a set of procedures to allow successful replication in New Mexico; and (3) when possible, has been determined to be cost beneficial.

### **Research-based**

A program or practice has some research demonstrating effectiveness but does not yet meet the standard of evidence-based.

### **Promising**

A program or practice, based on statistical analyses or preliminary research, presents potential for becoming research-based or evidence-based.

Same Goal, Different Results

**WILSON Reading System<sup>®</sup> (WRS) = mixed effects**

**READ 180<sup>®</sup> - Adolescent Literacy = evidence-based**

**LANGUAGE!<sup>®</sup> - Adolescent Literacy = no effects**

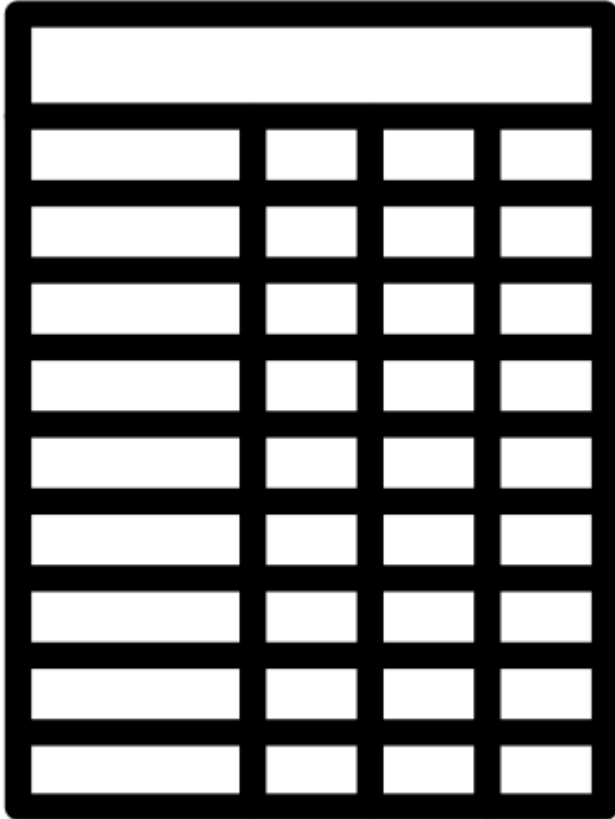
# High-Profile Ineffective Programs

**Scared Straight = Negative Effects**

Drug Abuse Resistance Education (DARE) = No Effects

Mass Media Campaigns to Prevent Illicit Drug Use of Youth = No Effects

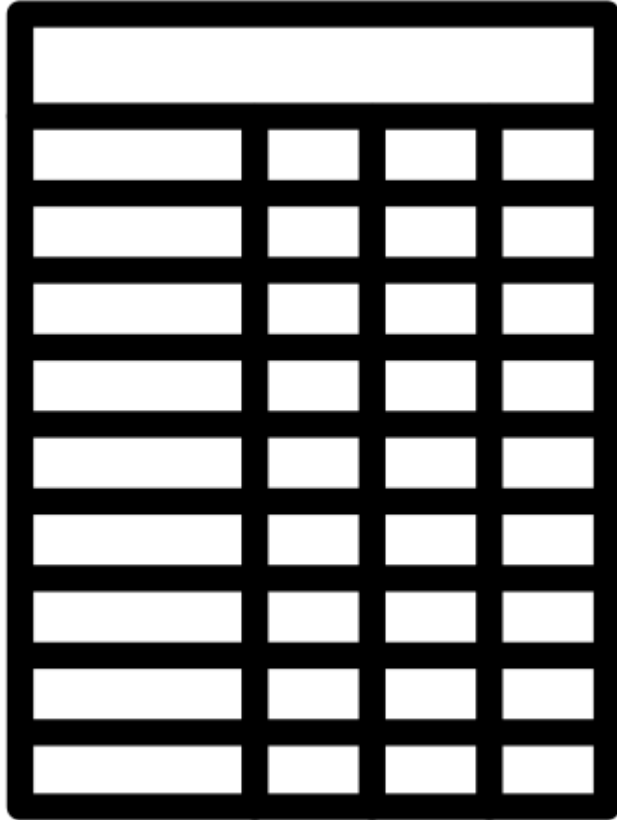
# What is a program inventory?



A comprehensive list of currently funded programs in a specific policy or outcome area, including whether they are supported by rigorous evidence.



# What is a program inventory?



Allows you to answer:

- What programs is my agency funding?
- Are they likely to work (i.e., achieve the desired outcomes)?
- What programs should be prioritized for evaluation?
- What programs have additional capacity?

# What do we mean by programs?

Systematic activities that engage participants in order to achieve discrete and desired outcomes

***Examples:***

## ***Educational Programs***

- Career Technical Education (CTE)
- Breakfast After the Bell
- Attendance interventions for chronically absent students
- Dual enrollment/credit
- Drug Abuse Resistance Education (DARE)

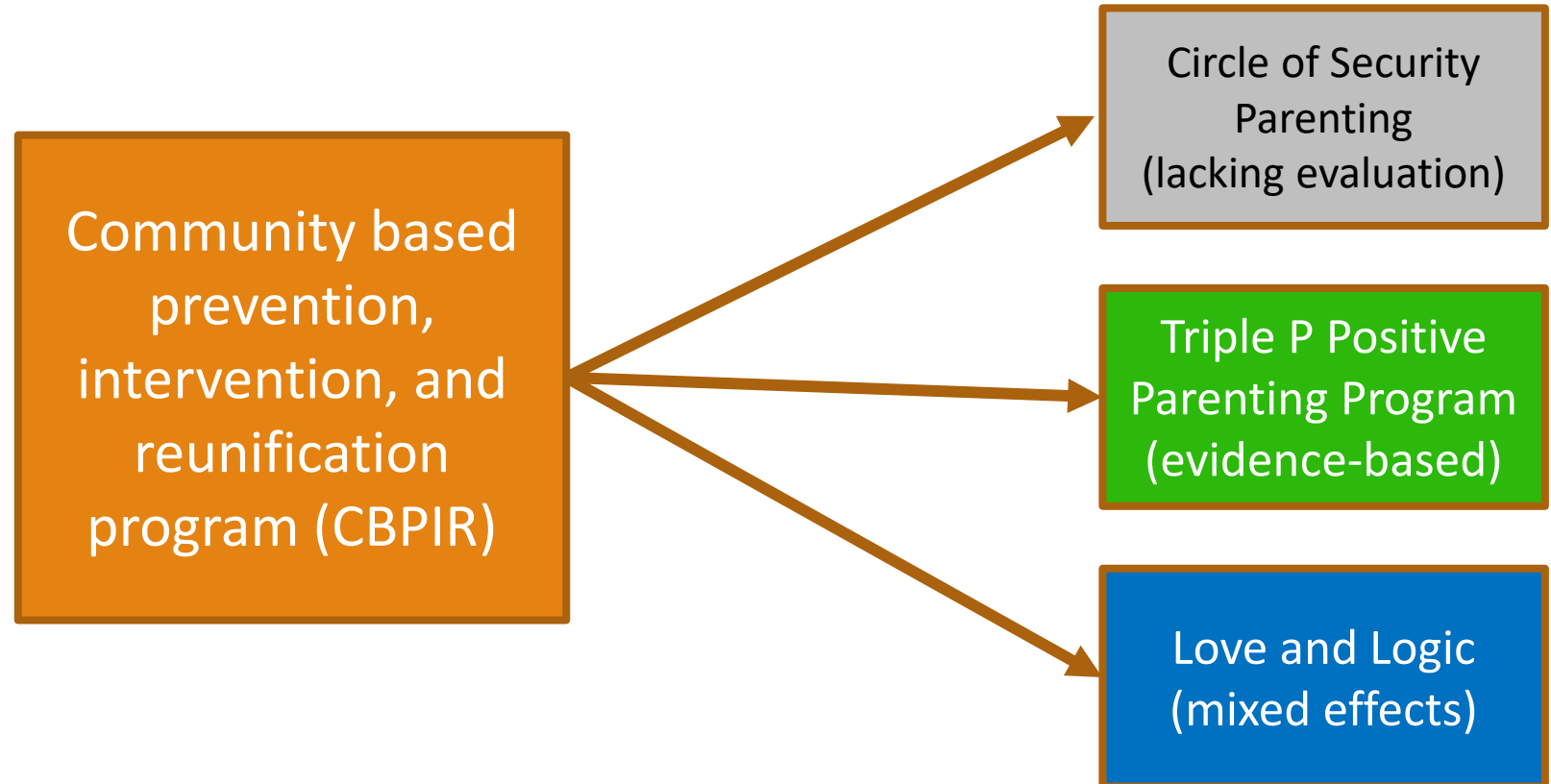


# Ideally broader programs can be broken down into programmatic components

***Example: CYFD CBPIR***

**Desired outcomes:**

- Improve parenting skills**
- Reduce the likelihood of child maltreatment**

# What is a clearinghouse?

---



Identify “what works”

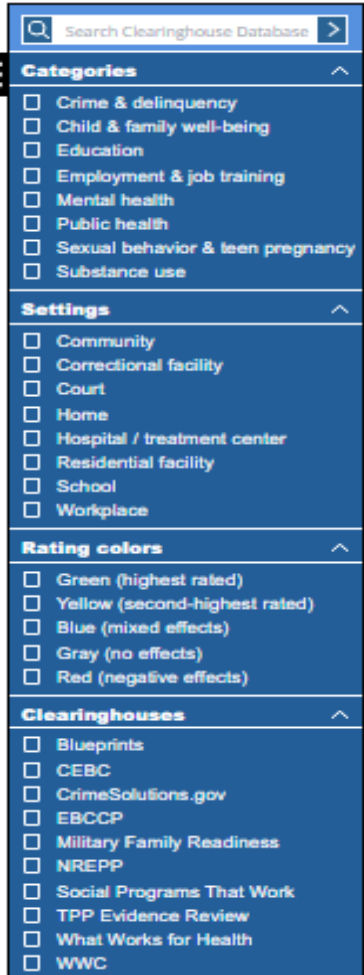
Review and summarize rigorous evaluations of programs and practices

Assign ratings based on the evidence (e.g., evidence-based, promising, mixed effects)

Use slightly different methodologies, criteria, and terminology

Policy area specific

# What is the Results First Clearinghouse Database ?



Free public resource

Contains information from 10 clearinghouses

Features over 4,666 programs and practices

Operated by Penn State University's Social Science Research Institute

# What are the evidence ratings in the inventory template?

Inventory Ratings	Definition
Evidence-based	Research with the highest level of rigor shows a statistically significant positive impact.
Research-based	Research with a high level of rigor shows a positive impact.
Promising	Research needing more rigorous evaluation to confirm impact.
Mixed Effects	Research where multiple studies have found variable impact
Lacking Evaluation	Program where no evaluation has been conducted to determine impact
No Effects	Research has found no impact of the program
Negative Effects	Research finds negative impacts

# How are programs rated by the Clearinghouse Database?

Clearinghouse Database Rating	Inventory Rating
Highest Rated	Evidence-based (Strong Evidence)
Second Highest Rated	Research-based (Good Evidence)
	Promising (Some Evidence)
Mixed Effects	Mixed Effects
	Lacking Evaluation
No Effects	No Effects
Negative Effects	Evidence of a negative impact

# Completing a Program Inventory

---

# Program inventory steps

---

1. List each program funded by the agency, along with general information
2. Provide cost and participant information
3. Determine the evidence rating

# Step 1: List each program and provide basic information

---

- Program name
- Brief description
- Average duration
- Length of program
- Age of participants

# Step 1: List each program and provide basic information

---

- Program name: ACT/SAT Test Preparation and Coaching Program
- Brief description: Test coaching to increase student scores on college entrance tests
- Average duration: 24 lessons, each one hour long
- Age of participants: 16-18

# Step 2: Provide participant information

- Total participants served
- Capacity of program
- Total number of participants eligible to complete program
- Total number of participants who completed the program

# Step 2: Provide participant information

- Total participants served: 95
- Capacity of program: 100
- Total number of participants eligible to complete program: 95
- Total number of participants who completed the program: 85

# Step 2: Provide cost information

- Total expenditures
- Total expenditures from state funds
- Federal fund expenditure
- Annual cost per participant
- Year of costs (if not FY24)
- FY25 budget
- FY26 request



# Step 2: Provide cost information

- Total expenditures: \$360,000
- Total expenditures from state funds: \$200,000
- Federal fund expenditure: \$160,000
- Annual cost per participant: \$240
- Description of per participant costs: \$360k / 95 participants
- Year of costs (if not FY24): N/A
- FY25 budget: \$450,000
- FY26 request: \$540,000

## Step 3: Determine whether programs are evidence-based

- Program matched to Clearinghouse Database
- Program rating (if in Clearinghouse Database)
- Link to research if not using Clearinghouse Database
- Note regarding evidence base

## Step 3: Determine whether programs are evidence-based

- Program matched to Clearinghouse Database: **Yes**
- Program rating (if in Clearinghouse Database): **Evidence-based**
- Link to research if not using Clearinghouse Database: **N/A**
- Note regarding evidence base: **ACT/SAT Test Preparation and Coaching Programs were found to have positive effects on general academic achievement (high school) for high school students, with a medium to large extent of evidence.**

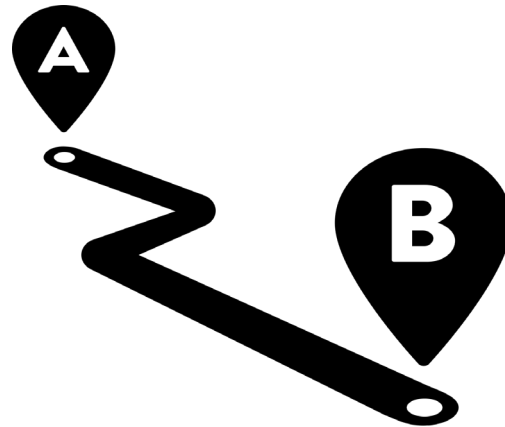
*EVEN IF THE PROGRAM HAS BEEN INDEPENDENTLY EVALUATED!*



# Steps for matching programs to the Clearinghouse Database

---

1. Search for matching programs in the Database
2. Verify programs match
3. Include information from Database in program inventory



# Step 1: Search the Clearinghouse Database

1. Search for program by name

2. Select program from list

## HINT

*If your program doesn't appear in list, you can:*

- Perform an alternate keyword search*
- Assess whether program from list matches*

# Step 2: Verify the Clearinghouse Database program is a match

Check the following to verify the Clearinghouse Database program matches your agency's program:

- Program description
- Outcomes
- Setting
- Ages
- Target population





# Step 2: Verify the Clearinghouse Database program is a match

**Aggression Replacement Training® (ART®)** ✕

Clearinghouse:

Aggression Replacement Training® is a cognitive-behavioral intervention that targets aggressive and violent adolescent behavior. The program consists of three components: Social Skills Training; Anger Control Training; and Moral Reasoning. The components are specifically matched across each week and integrated for content and process. Each week builds upon the week before. Clients attend a one-hour session in each of these components (meeting the same time and same day each week). [Read less](#)

The following information should be provided for matched programs:

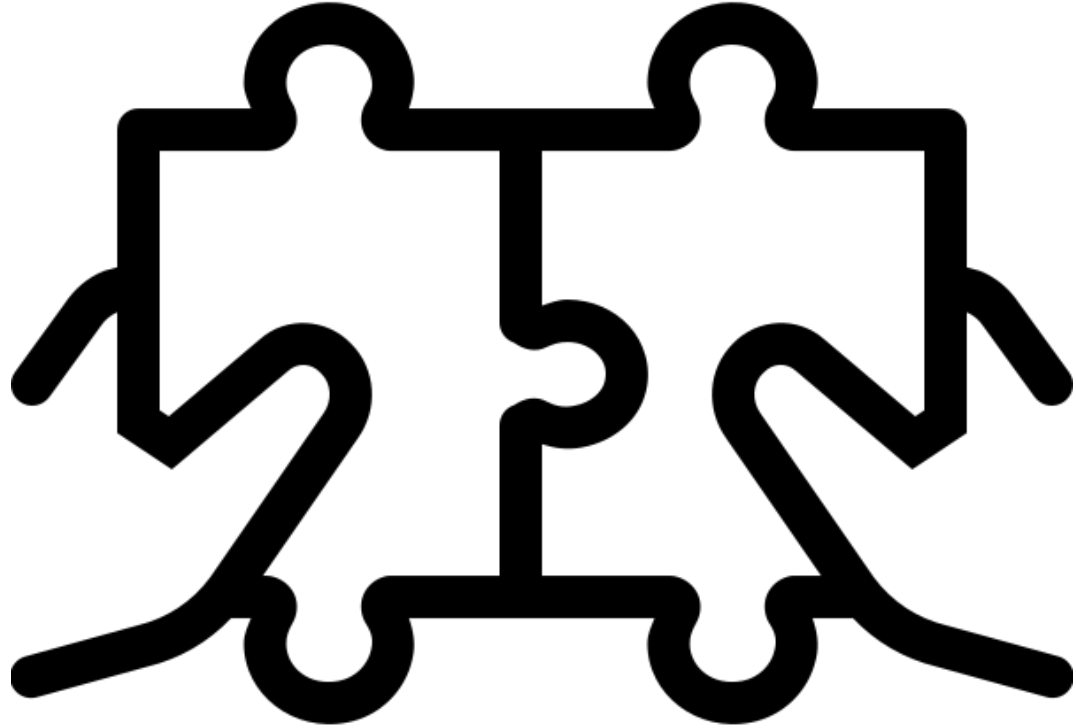
1. Program matched to the Results First Clearinghouse? (Y/N)
2. Program rating for matched programs
3. Notes regarding evidence base

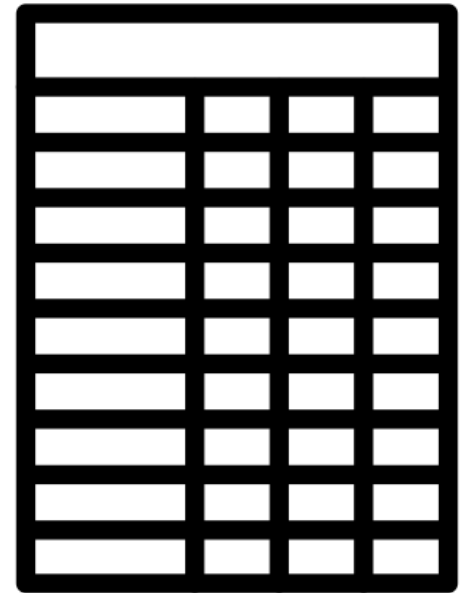
# Starting the program inventory *continued*

4. Attempt to match each program to the inventory

5a. If a clear match is found, include the relevant information in the inventory

5b. If your agency is unsure about a match, include the relevant information in the inventory, along with information about why you think it could be a match and what your concerns are

5c. If no match is found, provide a brief description of the process you used to locate a match and why do you think there is not a match
