### **PEC'S ROLE**

The PEC includes 10 independently elected members, each serving four-year terms across New Mexico's geographic districts. We focus on expanding access to high-quality, innovative and equitable public education. Our role is to ensure that charter schools serve <u>all</u> students well–academically, financially and organizationally–while offering New Mexico families diverse and accessible public school choices.

Unlike districts or PED, the PEC's sole responsibility is charter authorization. We approve schools, monitor performance and intervene when needed to protect students and public trust.

# **New Application Process**

- Clear, criteria-based rubrics aligned to: community need, academic model, financial sustainability & governance readiness
- Structured review timelines
- Formal community input and PEC hearings

#### **Renewal Process**

- Full performance evaluation every 5 years (including all annual report information)
- Includes academic trends, site visits, organizational & financial health
- Staff recommendations reviewed and final decision by PEC in public meetings

ACCOUNTABILITY MODEL

# **Annual Performance Reports**

- Evaluate academic outcomes (with attention to subgroup growth), financial viability, alignment w/mission-specific goals & compliance with governance standards.
- Issued annually and made public (improved public dashboard planned)

#### **Renewal Cycle Oversight**

- Focuses on multi-year performance trends
- Informs renewal decisions based on holistic performance and impact

LADDER OF INTERVENTION

Ensures early identification, responsive support, and decisive action when needed. Tiered response system for red flags or emergency conditions:

- Tier 1: Annual Reports and Monitoring
- Tier 2: Notice of Concern
- Tier 3: Notice of Breach
- Emergency Protocol: Immediate PEC response to financial, legal, or safety risks

# **DUAL ACCOUNTABILITY STRUCTURE**

Charter schools must meet both traditional public school standards and charter-specific performance expectations.

- Public Education Department Requirements: Academic outcomes, graduation standards, educator evaluation, and financial reporting
- Additional Charter-Specific Oversight: Charter Schools Act and PEC Performance Framework around mission fidelity, governance, and renewal benchmarks

# **PEC PERFORMANCE FRAMEWORK**

Each year, every school receives a public evaluation of their academic, financial and organizational performance to promote improvement, set clear expectations, and document results per PEC rule NMAC 6.2.9.11.

These evaluations inform PEC decision-making, provide transparency to the public, and offer schools a clear view of their strengths and areas for growth.

# **INNOVATION IN AUTHORIZING AND ACCOUNTABILITY**

For each performance indicator, the PEC has determined the performance measure and performance criteria. For 1.A. and 1.B. in the Academic Framework, the PEC has embedded school choice in selecting performance measures. This provides flexibility for a school to demonstrate academic performance that is directly aligned with its mission, vision, and educational program and meets the needs of its families.

In response the the Martinez/Yazzie lawsuit, through 1.B., the PEC also reviews achievement gaps in academic growth between student subgroups in each charter school.
