Federal Funding Update

Coronavirus Pandemic Funding Administered by DFA

Coronavirus Aid, Relief, and Economic Security Act (CARES) (closed in December)

- Budget: \$1,169,127,188.39
- Remaining (to be closed out): \$5.5

Emergency Rental Assistance Program I (ERAP)

- Budget: \$172,081,423.00
- Remaining: \$34,694,168.98

Emergency Rental Assistance Program II (ERAP)

- Budget: \$49,091,575.00
- Remaining: \$49,091,575.00*
 - *will kick in after ERAP I

Homeowners Assistance Fund (HAF) (DFA MOU to MFA)

- Budget: \$47,406,781.00
- Remaining: \$47,250,012.72

American Rescue Plan Act (ARPA) Federal Funds Appropriated by the NM Legislature

- Budget: \$1,594,013,828.00

GEER Funding

Governor's Emergency Education Relief Fund

This funding awarded grants to Governors for the purpose of providing Local Education Agency (LEA), institutions of higher education (IHEs), and other education-related entities with emergency support because of the COVID-19 pandemic. GEER funds for an LEA are intended to support its ability to continue to provide educational services to its students and to support the ongoing functionality of the LEA.

GEER I Education Agency Funding

- \$4.67M Early Childhood Education and Care Department
 - Programming for PreK Students, Home Learning Support, and Social and Emotional Support
- \$13.79M Public Education Department
 - Online Learning and Professional Development (Including Tribal Colleges)
- \$3.79M Higher Education Department
 - O Digital Devices and Connectivity, PPE, Building Sanitation and Cleaning Supplies, Social Emotional Support, Supporting students with special needs or in need of at-risk services during a building closure or transition back into the school building, Emergencies and Emerging Needs, Support for Tribally Controlled Schools and Tribal Departments of Education, Childcare During Building Closures, Rapid Response, Air Filtration Needs.






Future ARPA Dashboard


ARPA Dashboards will provide public updated spending data by agency and initiative.





Future ARPA Dashboard







ERAP Dashboard

ERAP Dashboard will provide public updates on awards for both rent and utilities by county and relocation assistance data. This showcases how effective this program is at aiding renters and providing landlords with an alternative to eviction.

As of April 25, 2022, we have issued 51,797 awards totaling \$122,912,595.1







Appropriation Contingency Fund

Brief update on special programs using Appropriation Contingency Fund.

Appropriation Contingency Fund

Disbursement of \$15 million to New Mexico Mortgage Finance Authority ("MFA")

These funds are for expenditure for energy-efficient affordable housing pursuant to the New Mexico Housing Trust Act.

Subaward Grant Agreement being finalized (suspense date: April 27, 2022)

Acute Care Hospital - \$50 million

These funds are to plan, design, construct and furnish an acute care hospital in a county with a population of less than one hundred thousand (100,000)

- Subaward Grant Agreement executed with Valencia County (March 4, 2022)
- 10% Disbursement (\$5 million) not yet requested
- Leveraging ~ \$28 million levy adopted to support operations of the hospital
- RFP issued for Hospital Partner (assist with the design)

Appropriation Contingency Fund

Disbursement of \$45 million to DFA for Regional Recreation Centers and Quality of Life Proposal (\$5 million from GF)

These funds are to plan, design, furnish and equip regional recreation centers and quality of life projects statewide.

Invitation to Submit Project Applications for Fiscal Year 2023

- This funding exists to improve the quality of life for New Mexico residents by creating new or expanding existing regional recreational facilities. These recreational facilities are defined as any project that will contribute to the quality of life for regional residents.
- Some examples of these recreational facilities could be a skatepark, rodeo grounds, trail enhancements, picnic shelters, or structures that enhance public based recreational activities.
- No more than twenty-seven million five hundred thousand dollars (\$27,500,000) of this appropriation shall be expended in a single fiscal year.
- Five million dollars (\$5,000,000) is from the general fund and the remaining amount is from the appropriation contingency fund.

Special Programs General Fund

Brief update on special programs and initiatives passed from the 2022 Legislative Session that use General Fund.

Hunger Initiative

NM Food Security Grant

The mission of the grant is to ensure that individuals and families throughout New Mexico have access to food, with a special focus on multi-sector collaborations that connect local food production with food insecure communities.

- Budget: \$10 million
- Funding categories: 1) Innovative delivery and distribution models, 2) Infrastructure funding for storage, aggregation, processing, and preparing food, 3) Start-up funds for cross-sector food security initiatives
- Invitation for Project Applications opens April 25, 2022, and will close May 20, 2022
- Projects announced by: June 1, 2022

Consolidated Budget

- Budget: \$14.7 million
- MOUs and budgets established across agency collaborative
- Fund transfers and reimbursements will begin July 1, 2022


Hunger Initiative Dashboard

Rural Partner's 'Pilot' Program - Catron, Grant, Hidalgo, Luna, Taos, Mesilla Valley Community (Doña Ana)

The purpose of this program is to hire individuals to locate funding sources for counties in the form of state and federal grant searches. The goal is to have a Rural Partner office in every New Mexico county.




