# **DHSEM In Action: FY22**

### **OCOVID-19**

- § Processed more than \$172 million dollars in FEMA Public Assistance funding
- § Operated a warehouse and helped distribute more than 15 million units of Personal Protective Equipment (PPE) throughout the pandemic
- § Regularly partnered with IAD, CYFD, DOH, DOT, NMDA, and the National Guard to provide food and water distributions to COVID-positive communities across New Mexico's tribes, pueblos, and nations.

### Natural Disasters

- § Collaboratively coordinated efforts to respond to and recover from the state's largest recorded wildfires in history by integrating federal, state and local efforts
- § DHSEM is actively administering 15 state emergency declarations in up to \$750,000 increments across the state for fire-related, flooding, and snow squall events

# **DHSEM In Action: FY22**

### Homeland Security

- § Conducted real-time threat monitoring and cyber threat analysis in advance of the primary, general, and special elections in 2020 and 2021
- § Established secure virtual environments to coordinate and deconflict cybersecurity efforts across the Secretary of State, National Guard, DHS Intelligence & Analysis, and various law enforcement agencies

### Finances

- § Reconciled State executive orders on our balance sheet which had never been done since the creation of the department. This allowed DHSEM to revert \$6.7 million to the General Fund
- § Following accounting and administrative improvements in FY22 our standing with FEMA drastically improved to such an extent that the department is no longer on any controlled draws for federal funding



# **DHSEM In Action: FY22**

### Programmatic

- § The Building Resilient Infrastructure and Communities (BRIC) grant makes federal funds available for natural hazard risk mitigation activities with an emphasis on promoting climate adaptation and resilience. For the federal fiscal year 2022, there is \$2.29 million available nationwide for the BRIC grant. The set-aside for New Mexico is \$2 million
- § DHSEM is moving our preparedness coordinators out of Santa Fe and into the regions they serve. We are also working with our federal and tribal partners to establish tribal emergency operations centers in the northern and southern parts of the state. The state will receive \$3 million in federal funding to support this effort and it is also anticipated that DHSEM will receive \$0.9 million in federal funding to upgrade the State EOC at our headquarters
- § To date, DHSEM administers 20 State Emergency Declarations for calendar year 2022, and increasing

# DHSEM in Action State Fire Marshal's Office

- **Code Enforcement**: Ensure the state's public buildings comply with national fire codes and are safe for occupancy. Code Enforcement will adopt IFC (International Fire Code) on November 1, 2022.
- **Service Support**: Conduct fire prevention outreach and education, coordinate with Insurance Service Office on risk ratings, and oversee the Fire Protection Grant Fund which aims to distribute \$29 million+ to local fire departments in FY23. Fire Support Bureau, in partnership with Red Cross and local fire departments, installed 200 smoke alarms (for approximately 100 homes) for FY 21 and FY22 combined. Fire Support has added a fire prevention specialist.
- **Investigation**: In 2020, SFMO established a first-of-its-kind Arson Task Force to investigate large fire incidents, combining firefighting, insurance, law enforcement, and legal experts to identify and convict arsonists investigated 220 fire in 2021. In 2022 investigations added a K-9.
  - → Led to more calls for assistance (from NM locals and surrounding states), a 51% increase in fire investigations from FY20 to FY21, and more arson prosecutions thanks to working relationships with DAs
- **Academy**: 2021Provide high-quality fire service training to roughly 4,000 first responders every year
- Completed construction of new burn building in April at NM Fire Training Academy
