

The NMYCC request is \$5,825.80, a 12% increase over the FY23 Operating budget. This figure incorporates \$1,285.3 from the fund balance.

The increase will cover the cost of cooperative agreements with EMNRD, and the State Land Office initiated with a Section 5 appropriation in FY22/23; the project award cap increase from \$150.0 to \$175.0; the personnel pay increase; and increased costs of materials (t-shirts, signs) that support YCC projects. YCC anticipates several projects related to fire recovery and prevention in FY24. YCC's fee to EMNRD for services is \$125 through FY26 per our MOA.

About 94% of the budget is used to fund youth projects or directly support corps members.



FY24 BUDGET REQUEST

The New Mexico Youth Conservation Corps (NMYCC) is funded with a governmental gross receipts tax (GGRT) distribution. The purpose of the agency is to fund local governments, tribes and nonprofits who manage employment and career development programs for youth ages 14 to 25. Youth improve the state's natural, cultural, historical, recreational and agricultural resources, and receive life, career and job training. Returning corps members may qualify for a \$1500 educational voucher or \$500 cash. The nine-member Commission is composed of five governor appointees and four state agency designees. There are two FTEs.

Corps Member Benefits By statute, the YCC offers a \$1,500 educational voucher OR a \$500 cash compensation to corps members who have worked on a YCC project for 48 weeks within a 48-month period.

In FY22, 33 corps members were eligible for benefits and contacted by the YCC. Nineteen youth responded; 12 have been paid and another 7 are in the process. The biggest hurdle to delivering benefits is lack of response from corps members.

Projects at a Glance, FY23

Major Accomplishments

YCC has a Cooperative Agreement for \$600,000 with EMNRD/Mining & Minerals, and one in progress for \$200,000 with the State Land Office. Both agencies will employ youth to perform mapping projects.

YCC is working with partners to develop a career kit for corps members.

YCC hired a new administrator in June 2022, and she is great. The position was vacant for a year.
