# New Mexico Governor's Commission on Disability FY17 Budget Request

Relatively flat request except for the addition of one position.

# **Programs:**

- Physical Accessibility: Site Visits, Plan Reviews, Residential Modifications
- Technical Assistance and Training: all Disabilities/all Age Groups
- Assistive Technology Program: Technology for Persons with Disabilities
- Brain Injury Advisory Council: Recommendations on services for Persons with Brain Injury
- Quality of Life Small Grants: one-time small grants to non-profits serving individuals with disabilities

#### **Narrative and Performance**

We have submitted an expansion request for an additional Architectural Access Specialist position. This position has been requested over the past three fiscal years. The current demand for conducting both plan reviews as well as site inspections of public facilities for compliance with accessibility requirements cannot be met with only two staff. Both, the plan reviews and the site inspections, identify existing, non-compliance accessibility issues that are barriers for persons with disabilities. Most requests for these services come from the public, architects, engineers and building code officials.

Staff conducts accessibility surveys to determine compliance includes surveying accessible parking, accessible routes, entrances to facilities, interior circulation paths, restrooms and various other elements within a facility. The two employees also review construction plans verifying compliance with current accessibility design standards. Plan reviews are followed up with a detailed written report and contact with the designer. Site Accessibility Surveys are also followed up with a written report, complete with photographs, on the assessment of a facility per detailing compliance responsibilities. Other requests for information include discrimination practices pertaining to the built environment, employment, housing, public schools, recreation sites, voting/polling sites and transportation.

In addition, we are in the process of resurrecting our **statutory** 'Residential Accessibility Modifications Program.' This program was halted back in 2006 due to complications that existed at that time. We have asked to use our Fund Balance to re-establish these activities including the installation of grab bars, ramps, toilet seats, transfer showers, widening of doors and other equipment into the homes of qualifying applicants. The expansion item requests an additional position which would coordinate this program.
