\$94.3K: Funding for a Pretrial Program Manager or Supervisor. Pursuant to an MOU, the AOC has agreed to reimburse the district for the compensation costs of the position in FY23.

\$102.4: Funding for 2 Pretrial Services Officers. Pursuant to an MOU, the AOC has agreed to reimburse the district for the compensation costs of the positions in FY23.

\$41.2K: Funding for a Bailiff Security FTE to be based in Guadalupe County to provide security for the district's two courthouses there.

\$66.4: Funding to convert an existing Attorney Associate FTE position into a Domestic Relations Hearing Officer/Special Commissioner FTE position

\$44.0K: Funding for Domestic Relations Mediation/ADR. This is a request for funding to provide domestic relations mediation, priority consultations, and advisory consultations to the district for pending cases.
