## Current Projects & Reports

- NMSC produces a series of annual reports concerning prison populations, meritorious deduction, and controlled release. These and other issue-specific reports are available on: [nmsc.unm.edu/reports](https://nmsc.unm.edu/reports)
- Newly established Crime Reduction Grants Program: The Crime Reduction Grants Act, passed by the Legislature in 2019, tasked the NMSC with coordinating the disbursement of crime reduction grants to Criminal Justice Coordinating Councils in the state to support local-level innovation in criminal justice systems. The program launched with a data integration program that awarded grants to develop a criminal justice data sharing network and governance infrastructure.
- The NMSC has been charged with overseeing a program to integrate criminal justice data systems across the state. The first step of this effort is to implement the use of a unique identification number for offenders to be used in all criminal justice records pertaining to that person.
- The NMSC is spearheading an effort to create standards to collect better racial and ethnic data in the state's criminal justice systems.

### Institute for Social Research (ISR)

NMSC is a research unit housed within ISR. ISR is a well-regarded provider of program evaluation and policy research in New Mexico. Known as an authority on adult and juvenile justice issues in New Mexico, ISR staff members and faculty affiliates also have expertise in the fields of education, economics, substance abuse treatment programs, poverty and homelessness, domestic violence, employee workloads and staffing levels, election sciences and administration, evaluation research, public policy, and public administration.

## NMSC Committees

### Justice Information Sharing Council (JISC)

JISC is a statewide criminal and juvenile justice agency team with the core mission of improving efficient and timely sharing of criminal justice data through the use of information technology.

### Juvenile Committee

The Juvenile Committee focuses on New Mexico juvenile justice issues. The committee visits programs and facilities throughout the state and makes recommendations to the Full Commission as appropriate.

### Legislative Committee

The Legislative Committee operates during the Legislative Sessions and makes recommendations to policy makers on justice-related legislation.

### Reform Committee

The Reform Committee's work is focused on advising the Executive, Judicial, and Legislative branches of government on policy matters relating to criminal and juvenile justice, and making recommendations to the Executive and Legislative branches of government concerning proposed changes to laws relating to the criminal and juvenile justice systems that would improve those systems.

### Sex Offender Management Board (SOMB)

The core mission of the SOMB is to develop and recommend to the Full Commission the best practices in the management and treatment of adult and juvenile sex offenders, while protecting current victims and preventing future victims of sex offenses.
