


# Suicide rates among NM youth 15-24 years by race/ethnicity, 2005-2009


# Suicide rates among NM youth 15-24 years by race/ethnicity, 2007-2011

### Like Any Community...

- Stigma and other cultural barriers
- Awareness of warning signs
- Access to mental health supports/services
- Substance abuse issues
- Potential unique aspects related to historical trauma, cultural/community identity, or isolation



### SB 417 - Clearinghouse

- Enacted initially on March 31, 2011 without funding
- FY13 funding: \$100,000 direct allocation to UNM via legislation
- Initial Plan for Clearinghouse
  - Technical assistance and support
  - Information and coordination
  - Resource development
- At request of state and other partners has been based out of Center for Rural and Community Behavioral Health (CRCBH)



#### **CRCBH Initiatives Since Enactment**

- Inform and engage tribes and other partners to assess the scope of the problem
- Partnership on development of tailored strategies with interested tribal communities
- Website development: <u>www.honoringnativelife.org</u>
- Grant-writing support, consultation and training
- Development of process for statewide advisory board/committee

### **Planned Initiatives**

- Statewide youth development activities such as leadership and life skills
- Coordination of scarce behavioral health resources using available expertise
- Support culturally appropriate statewide training for tribes on suicide prevention
- Support data management within tribal communities to advance prevention efforts and grant-writing
- Coordinate spring 2013 Prevention Summit
- Seek funding to sustain the clearinghouse
