

When one form of family violence is present, all members of the family are at risk!






Animal Abuse

- 76% of animal abusers also abuse another family member
- Animal Abuse alone is a serious crime... but, it can also be an indicator of other violence in the family

Why Laws & Policies Should Address and Incorporate "The Link"



CASE EXAMPLE: Bernalillo County deputies responded to a domestic violence aggravated battery call where the male offender had strangled and beaten the female victim who was his wife.

- Future was spotted by deputies with 3rd degree burns on his back.
- The male was charged with aggravated battery with great bodily harm domestic violence and extreme animal cruelty.
- The female later recanted—<u>but</u> the animalrelated charges remained and the male was indicted for animal cruelty.



New Mexico Law and Policy Needs

(a non-exhaustive list)

- More investment in **infrastructure** to respond to cases: e.g., funding for professional trainings, support for co-sheltering models, more support for program services like CARE
- Require and institutionalize cross-reporting between relevant agencies and professionals; a study may be warranted
- Amend the Family Violence Protection Act to include harm to a victim's companion animals as a type of domestic abuse and allow for protective orders to include animals
- Make animal sexual abuse (bestiality) illegal





Bestiality in New Mexico

This is a difficult topic to discuss.

But here's why it's important we do:

- > Yes, it is <u>sexual abuse</u> and it harms animals.
- > But it often does not lead to animal cruelty charges.
- > Fact: It is significantly connected to harm to children and adults.



> Yes, it happens in New Mexico.












Currently,
