## BernCo Probation Violation Hearings 10/29 10/30/2019

### Glossary:

FTR: “failure to report” (includes reporting for a drug test)

Arrest: includes any new violation of law alleged, whether actually arrested or not

Att: “attempted”

RTSMV: receiving transferring stolen motor vehicle

Res Burg: residential burglary

UTMV: unlawful taking of a motor vehicle

PCS: possession of a controlled substance

Felon in Poss: felon in possession of a firearm

Con: conspiracy

Agg Bat: aggravated battery

DW: deadly weapon

GBH: great bodily harm

CC: concurrent

FO DOC: “final out in department of corrections” (to serve the remaining balance of the prison sentence)

ATP: Addictions Treatment Program = 28 day detox program

RIN: Reinstate

SE: Set for

IOP: Intensive Outpatient Program

MDC: Metropolitan Detention Center (Bernalillo County Jail)

NMMRA: Men’s Recovery

NMWRA: Women’s Recovery
