New Mexico announces kids ages 5 to 11 now can now receive COVID-19 vaccine

NEW! \$1,500 Incentive Payments for Childcare Workers

New Mexico Early Childhood Education and Care Department will issue one-time incentive payments of \$1,500 to childcare professionals including teachers, administrative staff, cooks, and bus drivers. This grant recognizes the unique challenges that these essential workers face during the pandemic, while caring for and nurturing children. Deadline: December 1.

NEW! Children Ages 5-11 Eligible for the COVID-19 Vaccine

Children ages 5 to 11 are now eligible to receive the Pfizer COVID-19 vaccine. A dose of Pfizer for children 5-11 contains one-third the amount of active ingredient compared to the adult dose. Children would receive a second dose 21 days or more after their first. New Mexicans are encouraged to schedule their shots with their primary care physicians. They can also do so through the statewide vaccine COVID-19 vaccine registration system vaccineNM.org. Parents can visit vaccinenm.org/kids to add dependents to their existing vaccine scheduling profile. New Mexicans without access to the internet can call 1-855-600-3453 for scheduling assistance.

REMINDER: Activate Your \$100 **Incentive Cards**

The Department of Health reminds New Mexicans to activate their \$100 COVID-19 vaccine incentives if they have not already done so. The incentive will expire six months from the date individuals received the card (either by email, text, or a physical card). After six months, the incentive can no longer be claimed. L.B. Research and Education Foundation

The foundation provides grants ranging from \$10,000 to \$75,000 to nonprofit organizations that boost engagement and achievement for populations that face education opportunity gaps tied to poverty, gender, race/ethnicity, trauma, etc., and for health issues that are prevalent among vulnerable populations who face barriers to accessing adequate care. To apply: email a 400 word or less description of your funding idea.

Creative Forces Community Engagement Grant

Matching grants, ranging from \$10,000 to \$50,000, will be awarded for arts-based community projects that engage targeted military-connected communities. Deadline: December 15.

The Sustaining Cultural Heritage Collections Program

This program helps cultural institutions meet the complex challenge of preserving large and diverse holdings of humanities materials for future generations. It supports sustainable conservation measures that mitigate deterioration, prolong the useful life of collections, and support institutional resilience. Deadline: January 13, 2022.

USDA Farm to School Grant

Grants for activities such as training; supporting operations; planning; purchasing equipment; developing school gardens; developing partnerships; and implementing farm to school programs. Deadline: January 10, 2022.

Rural Residency Planning and Development Program

The purpose of this grant program is to improve health care in rural areas by supporting the development of new, accredited, and sustainable rural residency programs in family medicine, internal medicine, preventive medicine, psychiatry, general surgery, and obstetrics and gynecology, to address the physician workforce shortages and challenges faced by rural communities. Deadline: December 20.

COLLATERAL ASSISTANCE PROGRAM (CAP)

EDD can pledge cash to cover a collateral shortfall of up to \$250,000 for bank loans in order to enable financing that otherwise might not be available to a small business.

Special preference is placed on business owners who are women, US Veterans, ethnic minorities or part of other socially disadvantaged groups.

Special focus is on (but not limited to) projects in industries related to: intelligent manufacturing, sustainable & green industries, value added agriculture, tourism & outdoor, digital film & media located in rural areas.

NEW MEXICO MAINSTREET



New Mexico MainStreet acts as an umbrella organization, administering and providing professional technical assistance, services and resources to all its local affiliates.

- 31 MainStreet Programs (Active)
- 12 Arts & Cultural Districts (Active)
- 39 Frontier & Native American Communities Initiative Projects (Active & Complete)
- 4 Urban Neighborhood Commercial Corridor Projects
- 9 Historic Theater Restorations











New Mexico MainStreet Headquarters

New Mexico MainStreet Capital Outlay Program

Provides funding for public infrastructure upgrades within a targeted public investment area:

- Investments are scaled to a district's potential and catalytic commercial areas for economic redevelopment
- Based on an adopted Master Plan, Cultural Economic Development Plan, or Metropolitan Redevelopment Area Plan

NMMS works with local communities to identify catalytic economic development projects

- Uses a holistic approach that builds on existing assets
- Project must be an economic driver and demonstrate impact to local economy
- Improve the appearance and functionality of the district
- Create connectors
- Engage local property and business owners

Development of Construction Documents

- Includes Community Process
- NMMS CO Funding Requires minimum of 20 percent local match

NMMS Economic Vitality: Entrepreneurial Support Programs and COVID 19 Recovery Efforts

- New Mexico MainStreet has helped to launch several entrepreneur support programs in rural communities across the state.
- These programs are aimed at economic resilience and diversification through assisting small businesses, aspiring business owners, and entrepreneurs to launch and expand their operations.







Lovington MainStreet Local Innovators Institute

Local Innovators Institute in Lovington, NM - a food concept accelerator program that uses a shared food truck to help validate concepts and branding in a real-world working environment. Since launching its first cohort in 2019 it has helped launch and/or expand nearly a 1/2 dozen businesses in Lea County

- The Institute provides seven weeks of educational and hands-on training to culinary entrepreneurs.
- Each entrepreneur occupied the Institute's food truck for two weeks to build their business and sell their product.
- The program positions Lovington as a destination by creating a dining and entertainment district downtown.
- The program launch was funded by a \$75,900 grant from USDA in 2019. USDA has also funded a \$50,000 grant to continue the program in 2020-2021.

Gallup MainStreet and Arts Cultural District

HatchIT boot camps and the entrepreneur resource center in Gallup, NM.

- Gallup MainStreet ran a series of entrepreneur boot camps in 2020 and 2021 aimed at underserved and underrepresented founders in the Gallup area.
- Over 20 entrepreneurs have participated in these bootcamps and many have continued to work on their ideas post program.
- The Gallup MainStreet entrepreneur resource center also offers classes on marketing, design, and general business on a regular basis.









Taos MainStreet – Business Alive

Taos MainStreet, UNM-Taos, Taos HIVE, and Taos High Tech launched the Business Alive program to help local businesses develop and/or increase their e-commerce capacity. The first cohort of the program is launching 10 websites for local businesses. Business Alive also received support from the LOR Foundation and the Taos Community Foundation.

'Cash Mob' Virtual Events:

Six NMMS districts have used 'Cash Mob' virtual events to support local businesses during the pandemic and holiday season: Raton, Las Vegas, Clovis, Tucumcari, Silver City, and Farmington's Northwest New Mexico Arts Council.

Events hosted on Facebook Live allow shoppers to bid on items, arrange payment and socialize during the fun two-hour session. Lively hosts entertain and educate as they sell items and encouraged viewers to shop local to contribute to the community. 'Cash Mob' help businesses stay open and allow shoppers to buy local goods safely from home.
