

IAD is a resource for Nations, Pueblos, Tribes, Native American citizens in New Mexico and other governmental and non-governmental entities.


IAD does not provide direct services, however, IAD is serves as a resource to connect entities with resources and to ensure the voices of Indian people and communities are heard.

- Build Capacity
- Solidify the work and be intentional in the scope and direction.
- Develop and strengthen the agency's skills, abilities, and resources to adapt and thrive in its Vision.
- Ensure the voices of Native American citizens in New Mexico continue to be heard.







# **Grant and Funding Priorities**

## Tobacco Cessation & Prevention Program (TCPP)

Funding to Promote cessation strategies and interventions for commercial tobacco use in NPT populations that are culturally focused.

FY25 goal to expand grant opportunities to Tribal serving entities in addition to NPTs.

Grant period still open.

## Veteran's Grant Opportunity

FY25 IAD Operating Budget special funding focuses on Veteran Groups in NPTs.

Intended to promote the wellbeing of the NPTs Veteran population.

Grant period still open.

## Indigenous Youth Council (IYC)

21 youth (ages 16-25) representing all NPTs.

Attended or presented at several events.

Actively recruiting new cohort.

Kinship Campaign – billboards and social media campaign celebrating "asking for help".



## State Tribal Collaboration Act (STCA)

- STCA NMSA 1978, 11-18-1 et seq.
  - Policies
    - Every state agency has a policy which can be found on IAD's website:

    - IAD is in the process of drafting a template policy which agencies may consider adopting and/or modifying as they see fit.
  - Summit; Training; Annual Reports
    - IAD participates and hosts the State Tribal Leader Summit
    - IAD created a new cultural competency which it is also leading. The first training was in person and held on September 11, 2024
      - To date, 86 State employees have taken the training
      - 8 training sessions CY24
    - Every state agency has an annual report, which is provided to IAD by July 31 of each year and can be found on IAD's website: <a href="https://www.iad.nm.gov/programs/tribal-consultation-and-collaboration/annual-reports/">https://www.iad.nm.gov/programs/tribal-consultation-and-collaboration/annual-reports/</a>
- IAD has 1 FTE committed to addressing tribal consultation and providing services to meet the needs of Native people in New Mexico
  - Technical assistance provided for 1 tribal consultation
  - Coordinates and facilitates bi-monthly Tribal Leader Calls
  - Assisted in coordinating the State Tribal Leader Summit





## IAD Programmatic Areas

# Tribal Environmental Justice (TEJ)

- 1 FTE dedicated as a liaison between NPTs and agency partners.
- Central resource for funding opportunities for Nations, Pueblos, Tribes.
- Regular communication with all Nations, Pueblos, Tribes.
- Vital role in many of the state's environmental, natural resource, energy, climate and cultural resource protection initiatives.

#### Behavioral Health/Suicide Prevention (BH/SP)

- 1 FTE dedicated to outreach, engagement and collaboration with NPTs and BH stakeholders.
- Active participant in the Behavioral Health Collaborative (BHC); Behavioral Health Planning Council (BHPC)
- Lead on the BH Collaborative Native American Subcommittee (NASC)
- Participated in several NPT community events.



# Missing and Murdered Indigenous Persons (MMIP)

#### **Current Overview**

- **Hired a new MMIP Lead, Shaniya Decker-** primary responsibility is following the State Response Plan & ensuring implementation of the plan.
- **MMIP Quarterly Meetings-** held quarterly meetings with State agencies and partners to facilitate updates regarding progress on how MMIP issues are being addressed.
- Missing in New Mexico- participated as lead agency with DPS
- Listening Sessions
  - 1st session at UNM School of Law, Oct. 24th 2024
  - 2<sup>nd</sup> session TBD with the objective of listening to concerns of families

#### **Moving Forward**

- Focus on the State Response Plan
  - Working on implementing Objectives 2b, 2c & 2d of State Response Plan
  - Focus will be on healthy relationships, parenting classes, information on what to do in situations of domestic/sexual violence, what to do in situations of MMIP, and working with state, federal, and tribal partners
- MMIP Awareness Day
  - Intend to host an event on May 5 in recognition of MMIP
