Job Training Incentive Program (JTIP)



JTIP reimburses qualified companies for a portion of expenses associated with training new employees in newly created jobs. Qualified companies are economic base, expanding, and financially viable.

- Manufacturers
- Start-Ups
- Non-retail service providers with at least 50% income from customers out-of-state (Call Centers, R&D and Engineering firms, Logistics, HQ & Shared Services, IT, and Technology)
- Green Industry (non-retail)
 - Businesses that exist for the sole purpose of contributing directly to preserving or enhancing environmental quality.
 - Ineligible industries include traditional agriculture/farming, construction, extractive industries, health care, retail, hotels and restaurants and gaming.

Local Economic Development Act (LEDA)



- Grants to local governments (municipality and/or county) to support expanding or relocating businesses which include new jobs and investment
- All grants are funded on a strictly reimbursement basis.
- Program Funding Uses:
 - Purchase, lease, grant, construction, reconstruction, improvement, or other acquisition or conveyance of land, buildings, or other infrastructure

Tax Revenue from LEDA Projects



Since FY16:

- \$124M+ more than the cost of these projects to the State of New Mexico
 - \$77M to New Mexico Counties
 - \$128M to municipalities
- Total economic output = \$4.7B



Collateral Assistance Program (CAP)



- EDD pledges cash to cover a collateral shortfall up to \$250,000 for commercial loans
- Special preference is placed on business owners who are women, US Veterans, ethnic minorities, tribal members or part of other socially and economically disadvantaged groups.
- Special focus on (but not limited to) projects in industries related to intelligent manufacturing, sustainable & green industries, value-added agriculture, tourism & outdoor recreation, and digital film & media located in rural areas.

- \$22.5M in capital unlocked with \$3.4M pledged in collateral
- 31 businesses assisted
- 279 jobs created/retained
- 370 expected to be created in 2 years
- 45% of funds went to female and ethnic minority led/owned businesses

Outdoor Recreation Division



- Outdoor Equity Fund: \$3M investment with 1st awards made in August
- Outdoor Rec Accelerator Grants: 3 grants awarded 70 businesses trained to-date
- Outdoor Recreation Trails Grant: \$7M to 22 projects in 2022
- Invested \$297,000 in Rio Grande Trail Projects
- \$1.985M EDA grant received to support the outdoor economy post-pandemic
- 23 high school students received paid internships to gain experience & learn about the outdoor economy
- WNMU will create the state's first outdoor/bike industry workforce certificate with ORD support of \$357,000





A Call to Action

Ensuring Strategy Success – Key Takeaways

- NM's business community needs to adapt to rapidly changing times and be prepared to pay higher wages, increase schedule flexibility and provide greater options to attract employees.
- NM's business community & economic development activists need to join calls for increased EDD funding from the legislature; provide financial assistance to local EDOs and COGs; put more boots on the ground; increase capacity to garner federal funding & grow resources
- EDD, HED, and the higher education system need to collaborate to give incoming students the information necessary to choose careers in high-demand areas; degree and certification programs must meet the current and future needs of industry in the state
- Policymakers need to recognize that major changes to the economy will require significant funding for EDD and economic development programs.



New Mexico cannot continue on the path it has pursued in prior years – this plan provides a new path forward and the state must now provide funding and take action.

Quarterly Economic Summary

New Mexico's total matched taxable gross receipts (MTGR) followed the state's seasonal trend of decreasing from Q2 to Q3, by 0.16%, shown in Chart 1. This seasonal decrease was noticeably lower than many pre-pandemic years. The retail trade sector, shown in Chart 2, continues to be the largest contributor to MTGR in New Mexico in Q3 FY22. The sector makes up nearly one quarter of the state's total MTGR. Additionally, the industry reported an 8% year-over-year (YOY) increase and an 18% increase compared to 2 years ago (Table 1).
