



Active membership as of 6/30/2015 SI *Deferred Compensation active membership count as of 6/30/2016


Benefit Payments Fiscal Year 2016



- Fiscal Year 2016 benefit payments totaled
 *\$1,034,659,654**
- *\$951,300,842* in benefit payments were paid to retired members that reside in NM
- *\$83,358,812* in benefit payments were paid to retired members that reside outside of NM
- **\$44,998,075** in refunded member contributions was also paid out in FY16
- **\$1,079,657,729** in total payments were made by PERA in FY16

NM Economic Impact

Pension Payment Impact

- *\$4.48* total economic activity in New Mexico for each dollar of employer contributions paid
- *\$1.2* billion in total economic output in NM in 2014 by PERA retirees
- *\$231.6* million in federal, state and local tax revenue generated by spending of PERA pension income
- *8,253* jobs created from pension income spending by PERA retirees

PERA Employment Impact

- PERA employs *84 FTE 7 current vacancies*
- FY16 payroll, including benefits was: *\$ 6,155,000*
- PERA Fund value as of 6/30/2016:
 \$14.0 billion
- Deferred Comp Value as of 6/30/2016: \$501,309,987 million
