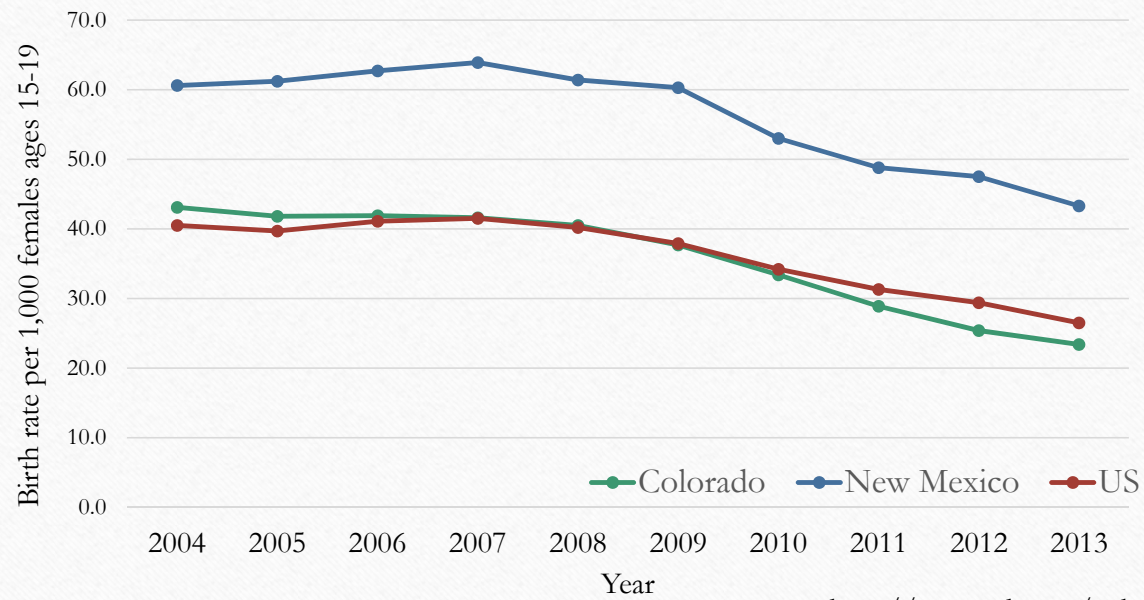

DOH Delayed Parenthood Project Program Structure

- **Focus on 13 target areas** with high teen birth rates/high numbers of at-risk teens. Focus areas are Bernalillo (Albuquerque), Cibola (Grants), McKinley (Gallup), San Juan (Farmington), Rio Arriba (Española), Santa Fe (Santa Fe), Taos (Taos), Chaves (Roswell), Lea (Hobbs), Eddy (Carlsbad), Doña Ana (Las Cruces and Anthony/Sunland Park), and Luna (Deming).
- **Public-private partnership:** private funds used to kick start and sustain the program. Program will launch with no additional general fund funding.
- **Community specific approach** using multiple methods to broaden public support.
- **Maximum federal reimbursements** from Medicaid and other sources.
- **Effective marketing:** reaching at risk populations with social media and other means that are credible and lead to change.
- **Expanded provider network** in geographical target areas.

DOH Delayed Parenthood Project Program and Financial Targets

- Reduce associated public costs by \$36.4 million/year incrementally over the initial four year project term.
- Reduce teen birth rates in New Mexico by 50 percent over four years.
- As demonstrated in CO, it is expected that NM will experience reduced abortion rates.
- It is also expected that there will be a decrease in high school drop-out rates.
