On behalf of the New Mexico Food & Agriculture Policy Council, Agri-Cultura Cooperative Network, and La Semilla Food Center, we are very grateful for the opportunity to participate in a panel presentation about New Mexico's food, hunger, and agriculture systems current issues and legislative priorities. Healthy Food Financing Initiative (HFFI):

The HFFI is an effective, viable, and economically sustainable solution to bring locally-grown food and jobs into under-served communities without sufficient access to affordable, nutritious foods. The fund is a combination of public and private dollars that can achieve multiple goals: reducing health disparities and improving the health of families and children; creating jobs; and stimulating long-term local economic development in low-income communities. Please find enclosed two infographics describing the statewide Healthy Food Financing Initiative (HFFI) that we will be presenting during the Legislative Health and Human Services Interim Committee hearing.

NM Grown Fruits & Vegetables to Schools & Senior Meals Programs:

Building on the multiple year work to establish the NM Grown for School Meals Program and a recently completed pilot program to establish opportunities for New Mexico Senior Centers to buy New Mexico grown fruits and vegetables for their meal programs, we are working on a more comprehensive inter-agency approach to mitigate hunger and increasing nutrition through public food and nutrition programs. At the same time, we are increasing economic market opportunities for farms to supply produce, and possibly other farm products, to multiple institutions: schools; senior centers; childcare facilities; and, inter-generational food and nutrition programs.
