





BUILDING BEHAVIORAL HEALTH IN NEW MEXICO

TURQUOISE CARE IMPROVEMENTS

- Raising BH Medicaid reimbursement rates up to 150% of Medicare rates.
- 6 Certified Community Behavioral Health Clinics (CCBHCs) slated to launch January 2025.
- Added 5 new Behavioral Health Practices for enhanced rates, encouraging more providers to expand their services.
- Added Community Health Workers as Medicaid providers
- CARA members receive delegated care coordination, supporting them with substance use disorder recovery
- Justice Re-entry program: received federal approval to reach into jails/prisons up to 90 days prior to release with Medicaid-covered MAT services, 30-days medications, and care coordination.

Positive trend in increasing Medicaid members' access to behavioral health visits continues.

BUILDING BH BY EXPANDING CRISIS SERVICES

Certified Community Behavioral Health Clinics (CCBHC)

- 6 CCBHCs have provisional status to begin services and billing on Jan 1, 2025
- HCA is recruiting for a new cohort of providers for additional CCBHCs

Mobile Crisis Teams

- Received CMS approval in February 2024
- 1 program has been certified, 5 in process


Crisis Triage Centers

- 4 CTCs are open and receiving Medicaid reimbursement
- 2 Crisis Stabilization programs are in process of full certification and reimbursement

Increasing Access to Medication Assisted Treatment





PRIMARY CARE & PSYCHIATRY RESIDENCY EXPANSION


Outcomes over the past 5 years (2019-2023)

- Since 2019, 3 new accredited, primary care rural residency programs have opened in NM growing the number of residencies from 8-11.
- Number of primary care residents in training increased from 142 to 191.
- NM residency programs have average 59% retention rate of residents practicing in NM after 3-years.

Expected Future Outcomes

- HCA supporting development of 5 additional residency programs by 2030.
 - Number of residency positions will grow to 230, a 70% increase by 2030.

HEALTH CARE DELIVERY & ACCESS ACT

HEALTH CARE DELIVERY & ACCESS ACT

(A MEDICAID DIRECTED PAYMENT PROGRAM)

- Lifts all hospitals, larger hospitals pay more, tiered funding based on performance, rural & frontier hospitals pay ~19% of the assessment and receive ~41% of the disbursements.
- Hospitals must report annually with evidence that at least 75% of the net new funding is spent in the state.
- Tracks quality performance based on the facility designation (Acute Care Hospital (Rural/Urban or Frontier), Long-Term Care Hospital, Inpatient Rehabilitation Facility, or Inpatient Psychiatric Facility.
- Distributes quality performance-based funding if performance targets are met, using tiered methodology.
- Expected implementation (dependent on CMS approval)
 - Estimated Payment Date for CY24 July-Dec: March 28, 2025
 - Estimated Quality Payment Date for CY24 July-Dec: May 30, 2025

40% of revenue is linked to quality performance
