





With state support, NextSteps will provide case management and workforce preparation and job placement support to up to 720 previously incarcerated individuals, including into the clean energy workforce.

# Highlights from Coalition Budget Feedback

- Caseload
  - Active Clients per Case Manager: 35-40
  - Additional Clients if services (like Goodwill's NextSteps) continue for up to a year and require less meeting frequency over time: +10-20 additional clients
- Peer Mentoring
  - Beneficial service
  - Job opportunities for previous clients
- Housing
- Behavioral Health Needs and Staffing

## **Ongoing Coalition Topics Include**

- Current capacity and infrastructure needs to expand to serve the County Jails and Pre-Trial justiceinvolved population
- Behavioral Health, further coordination with services
- What other providers would be interested in joining

### **Coalition Recommendations**

- ▶ 1. **\$10-10.5** million recurring funding to fund reentry workforce development service programs with wrap around services and training programs statewide.
- ▶ 2. \$13.8 million recurring funding to the New Mexico Healthcare Authority's RESET Program to address housing support needs (up to 6 months) for the reentry population statewide.
- 3. A Reentry Task Force including reentry providers and community members who are individuals with personal experience in the New Mexico correctional system to develop further recommendations for the Legislature.
