#### Direct Support Professional at \$11.56/hr

- Completes and maintains all required State mandated trainings such as Preservice, Foundations for Health and Wellness, Approved Medication Administration Protocol (AMAP), CPR / First Aid, Advocacy 101, Positive Behavior Support Strategies, Teaching and Supports Strategies, Participatory Communication, Indications of Illness and Injury, Abuse, Neglect and Exploitation Training; and all Individual Specific Training
- Knowledge of and skill in implementation of Comprehensive Aspiration Risk Management Plans, Ancillary Therapy Plans such as PT, OT, SLP
- Provides for activities of daily living by assisting with serving meals, helping eat as necessary; and ambulating, turning, and positioning individuals; and providing fresh water and nourishment between meals.
- Maintains individual health stability by checking vital signs and weight; recording intake and output information, monitoring blood sugar
- Observes individuals for evidence of injury or bruises and evaluates for changes in emotional and physical status;
- Assists in the implementation of individual plans for individuals and behavioral plan goals
- Documents actions by completing forms, reports, logs, and records.
- Maintains work operations by following policies and procedures.
- Protects organization's value by keeping individual information confidential.
- Ensures each individual's rights are protected;
- Treats individuals with dignity and respect;

## What is the Central Registry?

- Central registry is a database that tracks applications for the DD, Mi Via & Supports Waivers
- All Applications are assigned a "Status" depending on where the applicant is in the process
- There are Five (5) status types





## **5** Central Registry "Status" Types

- Start
- Complete
- Child Pend

Allocation on Hold

Allocation in Progress

Initial application phase

The person has met eligibility criteria and is a match for the program. These individuals are a "Yes Match". *Persons in this category are on the* "Wait List"

Children who have applied and will be reevaluated at the age of 9. If the child meets eligibility criteria upon reevaluation, they are moved into complete status and receive a registration date based on the original date of the application.

Person is allocated to the waiver yet elects to place their "Allocation on Hold" because they do not need services at that time. Allocation can be activated when necessary. *Persons in this category are on* the "Wait List".

These are persons actively enrolling in Medicaid so that they may commence services.

# Governor Michelle Lujan Grisham July 2019

"A waiting list of this size is completely unacceptable and indicative of a lack of care and attention by state leadership in recent years," Gov. Lujan Grisham said. "My administration is building a system that will provide high-quality services for New Mexicans with developmental disabilities and their families. Over time, this waiting list will be eliminated. I want it done now, but it will take time, and we are aggressively pursuing the remedy. Through our commitment to working with families, tribal leaders and other community stakeholders, we will deliver for the most vulnerable population in our state."







# LFC Program Evaluation Report 2018

#### **Key Recommendations**

The Department of Health, in consultation with the Legislative Finance Committee and Legislative Health and Human Services Committee, should:

Create a five-year plan to reduce the waiting list by 25 percent to 50 percent. Funding the plan would require the Legislature to commit a total of approximately \$4 million to \$8 million general fund for the first year of waiver services over the five-year period and approximately \$33 million to \$65 million on a recurring basis thereafter. This plan should then be submitted to the Legislature with annual DOH budget submissions, detailing progress toward the stated goal, and any changes in funding requirements year-to-year to support these new clients. Should DOH demonstrate cost containment in the DD and Mi Via waivers, the Legislature should consider reappropriating these savings to increase the rate the waitlist will be reduced in the five-year plan.

## The Jackson Lawsuit

- The "Jackson" lawsuit was brought in 1987 to correct unconstitutional conditions at two now-closed state institutions for people with developmental disabilities, and to remedy violations of the Rehabilitation Act which subjected people with severe disabilities to discrimination and unnecessary segregation.
- The US District Court for the District of New Mexico gave its final approval to a new Settlement Agreement in case in 2019.
- The Court concluded that the Settlement Agreement was fair, reasonable, and adequate because it established a durable remedy to cure the original constitutional and federal statutory violations which were found in 1990.





## Value of the Jackson Settlement Agreement

- Disengaged 8 of 10 obligations assigned to DOH in Jackson Settlement Agreement
- All 10 paragraphs must be disengaged plus evidence of sustained compliance is required to dismiss the entirety of the Jackson Lawsuit
- Value: In FY21 DDSD Nurses performed over 1200 Face to Face/Telephonic Nursing Visits for Class Members Statewide

## Home And Community Based Spending Plan

- Makes available 10-percentage point increase in federal matching funds for Medicaid home and community-based services (HCBS) from 4/1/2021-3/30/2022
- New funds must supplement, not supplant, the level of state HCBS spending as of April 1, 2021, and states must implement or expand one or more activities to enhance HCBS
- In order to receive the 10-percentage point increase in federal funding, a state must:
  - Preserve the amount, duration, and scope of covered HCBS;
  - Maintain, and not reduce, HCBS provider payments rates; and
  - Not impose stricter eligibility standards for HCBS programs or services.





## Home And Community Based Spending Plan

- Activities to "enhance, expand, or strengthen" Medicaid HCBS
- Enhanced FMAP is only available for one year, states have until March 2024 to reinvest
- Within 30 days states must provide CMS with their initial spending plan and narrative explaining the activities

## Home And Community Based Spending Plan: Workforce

- Temporary Economic Recovery Payments to all HCBS waiver and LTSS providers
- 15% payment in year one, 10% payment in year two, 5% payment in year three
- Recovery payments can be used for retention, PPE, hazard pay, training, infrastructure, technology improvements, direct bonuses to workers
