Partnering with New Mexico's communities to provide quality, sustainable school facilities for our students and educators.

PSCOC and PSFA Background

- Current public school capital funding process was developed and established in response to the 1998 Zuni lawsuit.
- New Mexico public school capital outlay process seeks to establish and implement a uniform funding system for capital improvements.
- Public school capital outlay funding is both a local and state responsibility in New Mexico.
- Public School Capital Outlay Council (PSCOC) manages the allocation of the Public School Capital Outlay Act Fund (PSCOF) to public school facilities in New Mexico's 89 school districts and 2 special schools (School for the Deaf and School for the Blind and Visually Impaired).
- PSCOOTF provides oversight of PSCOC.
- PSFA is staff to the PSCOC.

Four Primary Functions of PSFA

Staff to PSCOC

Role defined by NM Administrative Code.

Provide research and analysis to decision-makers on PSCOC.

Funding Administration

Distribution of state funding to all school districts, in compliance with statute.

Project Management

Partner with school districts on planning, design, and construction projects (including technology infrastructure) to provide project management support and technical expertise.

Facility Information Management

Assess, gather, and organize facility information for all schools in NM.

Calculate the wNMCI score to produce the statewide ranking of public schools.

Assist districts in monitoring and improving maintenance and energy efficiency.

Services provided to school districts

Capital Funding for Schools in NM

Local and state capital funding responsibility in NM:

- Protects local autonomy and authority of school districts.
- State funding supplements local funding to ensure uniformity.

Between 1999-2004, in response to the Zuni lawsuit and the need to create a uniform system for capital improvements, the State formulated a new “Standards-Based” capital funding program by:

1. Assigning the source for the Public School Capital Outlay Fund, supplemental severance tax bond proceeds.
2. Formulating the Phase 1 State/Local match calculation.
3. Designating the administrative and oversight bodies.
 - PSCOOTF → PSCOC → PSFA
4. Creating the Statewide Adequacy Standards, funding program.



Current Funding Programs Timeline

Standards, Systems, Pre-K applications and awards.

- Feb 1: Pre-applications sent to districts.
- Feb 12: Pre-applications due to PSFA.
- Feb 19 – Mar 11: PSFA site visits to pre-applicant districts.
- Apr 13: Full applications sent to pre-applicant districts.
- May 21: Full applications due to PSFA.
- June 14: District presentations to PSCOC.
- July 12: PSCOC makes funding awards (FY22).



Upcoming Meeting

Pre-K Applications for Funding and COVID

- 3 school districts submitted pre-applications for new Pre-K awards in February 2021.
 - Up to \$10 M in total estimated project cost.
- Each school district eventually pulled back their applications for Pre-K funding, citing uncertainty about the long-term impact of COVID on the Pre-K enrollment.
- COVID/remote learning reduced Pre-K enrollment statewide in 2020-2021.
- Districts are uncertain when/if the eligible 3 and 4 year olds will return to Pre-K programs offered in public schools.
- Based on input from districts, PSFA expects a return to \$10 M in annual application requests for Pre-K awards in 2022.

Overview of All In-Process Projects

- 376 active, in-process projects statewide.
 - Standards, systems, Pre-K, and security.

- 34 standards-based projects.
 - 27 in-process standards-based (large) capital projects awarded in the last 3 fiscal years (FY19, FY20, FY21).
 - 6 new standards-based projects starting in FY22 (if awarded in July).

- 36 systems-based projects.
 - Building system replacement projects (HVAC, roofing, fire alarm, doors, windows, finishes, plumbing, electrical, site drainage)

- 9 Pre-K projects.


- 297 security projects in design or construction.
